

CHAIRMAN'S WELCOME ADDRESS FOR THE 5TH TOWN HALL MEETING.

our Excellency, Distinguished Ladies and Gentlemen, I am delighted to welcome you all to the 5th Town Hall Meeting on Security with the Governor, His Excellency Babatunde Raji Fashola, SAN.

Let me first of all express my profound gratitude to all our donors for the support the Fund has received in the past four years. The task of raising funds to enable the security agencies carryout their functions has not been easy especially in the economic climate we find ourselves. Nonetheless, we have had worthy partners who have stood by us even in these difficult times and to them I say thank you so very much!

In the past one year, the Fund with the help of the State Government, other Public and Private Organizations and individuals have provided additional patrol vehicles, APCs, bulletproof vest, riders gear, walkie talkies, base radios and other security equipment for the police and other security agencies in Lagos State. The details of these items and the activities of the Fund in the past year would be presented by the Executive Secretary of the Fund.

I must mention here that His Excellency, in line with his statutory mandate, has reconstituted the Board

of the Fund to replace members who had left and to address the issue of Board tenure which came to an end on 7th November. The commissioners representing the state government on the Board Prince Lanre Balogun and Mr, Jide Sanwo-Olu were replaced by Mr. Gbolahan Lawal (Hon. Commissioner for Agriculture and Cooperatives) and Mr. Biyi Mabadeje (Hon. Commissioner for Science and Technology). Also, Dr. Reuben Abati, after his appointment as the Special Adviser on Communication and Media to the President of the Federation, was replaced by Mr. Opeyemi Agbaje. In addition, the Fund was further enriched by the appointment of First Bank of Nig, Plc. to the Board, and in demonstration of the regard the Bank has for this joint effort, its Group Managing Director, Mr. Bisi Onasanya committed to personally attend the meetings of the Board and has indeed attended his first one on 3 November 2011. All other members were retained on the Board as earlier constituted.

On behalf of the entire Lagos State Security Trust Fund family, I express our sincere appreciation for the inputs and sacrifices of the former members of the Board and wish them the very best in their future undertakings while I remind them that they are still integral parts of our family. To the new members, I say a hearty welcome.

We can all attest to the fact that a better equipped police translates to better effectiveness and improved security. However as written by Prof. Chinua Achebe in his widely acclaimed novel "Things Fall Apart", "when a hunter learns how to shoot without missing, the birds learn how to fly without perching". In essence, because crime is a business criminals will continue to think up new strategies to remain in that business, and so we in Lagos State must continue to review, refine and re-invent our responses in relation to the security challenges we face. There is no doubt that 2011 has been a most challenging year for security not just in

Lagos, but all across the country. I can say with some confidence that without the input of the Trust Fund our security personnel would not have been able to adequately respond to these challenges.

In recent times our country is confronted with unique challenges that have greatly compromised our internal security and have understandably distracted the Federal Government from focusing on regular law enforcement concerns of the country. These situations have created challenges on both fronts of our fight against crime, to wit: Fund Raising and enforcement of law and order. I would leave the details of the security situation in Lagos State to the Commissioner of Police, Lagos State Police Command, who is more competent to address the issue.

A major reality is the fact that in Lagos State the security agencies are heavily reliant on the Fund for basic tools to perform their constitutional functions and since there seems to be no alternative to this model we must continue to strive to provide the much needed resources for these agencies.

In the period of its existence, the Fund has indeed provided a lot of support for the police and other security agencies in the state in an unprecedented manner. I have already implied however, that we must refrain from thinking that we have completely resolved the issue of crime and protection of lives and property. Far from it. We need to continuously maintain and replace a lot of these assets because the equipment are applied 24 hours a day, 7 days a week, 52 weeks a year. This pressure on the assets means that their rate of depreciation is extremely high. There is therefore a significantly large cost involved in maintaining and expanding the operational capacity of security agencies. The security agencies require constant replacement of patrol vehicles, expansion of the fleet, undercover cars, Armored Personnel Carriers (APCs), motor bikes, ballistic and all weather gear for the men, communication equipment, fuel, welfare, training and retraining of the men. For emphasis, the security agencies assisted by the Fund include the Police (including RRS, Anti Terrorist Squad, Marine

Police unit, Zone II, MOPOL formations, state CID,), OP MESA (a joint military force- Army. Navy, Air Force), and the State Security Service.


Our greatest challenge therefore is sustaining what we have built over the years. The continuing and future effectiveness of our security model lies in our hands. 

GOVERNOR'S ADDRESS



considering the huge capacity gap that existed and acknowledging that the duty of resourcing was primarily a federal government obligation, then recommended a public-private partnership resourcing model as the only practical solution. The establishment of the Lagos State Security Trust Fund as the institutional model through which to provide operational capacity for the police and other security agencies in the state in an accountable manner was the result of this process.

Five years on, your state government with the continued support of its partners has invested substantially in security through the Lagos State Security Trust Fund, and I have remained personally engaged in all security and law enforcement matters. This investment of resources and leadership at all levels has indeed translated to a reduction in crime in our state relative to the crime situation in 2007. In 2007, 1036 vehicles were snatched in the state while in 2008, 2009, 2010, for the same period 796, 390 and 409 vehicles were snatched respectively. While 9 successful bank robberies were recorded in 2007, two were recorded in 2008 and one in 2009. Since then there have been a number of attempts to rob some banks which had been foiled by a better equipped police. We are not saying that we have achieved a crime free Lagos. We are aware that 2011 has been particularly challenging as compared to 2009 and 2010 as indeed it has been countrywide, in many cases much worse than here. And what we can say with confidence is that existence of the Fund has enabled our security agencies to give adequate response and bring the situation under control. In short, we are manifestly more prepared to combat crime.

As is customary, we have heard the Chairman's welcome address, the detailed report on the actives and functions of the Fund presented by the Executive Secretary and the briefing on the current security situation in the state including the comparative study of crime trends over the past two years by the Commissioner of Police.

SPEECH OF HIS EXCELLENCY **BABATUNDE RAJI FASHOLA** SAN, GOVERNOR OF LAGOS STATE AT THE FOURTH TOWN HALL MEETING ON SECURITY, HELD ON THE 22ND NOVEMBER 2011 AT THE CIVIC CENTRE, VICTORIA ISLAND LAGOS.

Protocols,

Distinguished ladies and gentlemen,

It is with great pleasure that I address you on the occasion of the fifth Town Hall Meeting on Security.

You would recall that at the beginning of our previous administration, we had promised to substantially address, within the context of our constitutional remit and the limit of our resources, the issue of security which was an understandable source of grave concern. To develop a definable policy on this, we first set up an all inclusive security committee headed by I.G. A.K. Smith (rtd) to study the matter critically and proffer solutions. One of the major findings of that committee, not surprisingly, was that though the security agents were willing to perform their constitutional duties they were ill-equipped to face the challenges they were faced with. The committee, recognizing that the state government could not bear the burden of resourcing the agencies alone,

Ladies and gentlemen, together we have greatly improved the operational capacity of the police and other security agencies in Lagos State and you have heard the details of this unprecedented infusion from the Executive Secretary. I believe we should, while acknowledging that the race is far from run, congratulate ourselves for the fruits of this unique joint-endeayour.

My very sincere thank you goes to every organization and individual that has identified with this partnership by way of donations to the Fund whether in cash or material. Your support has really been a source of encouragement to us and the over 22000 thousand security agents that have been empowered by your good citizenship. I must also thank our security agencies who continue to stand in harms way in order to prevent us from becoming victims of crime. In particular I must commend the team of 21 men who investigated and stormed the hideout of heavily armed robbers and kidnappers resulting in the arrest of 3 members of the gang, the rescue of 3 kidnap victims and the recovery of a lot of very dangerous weapons, including, significantly and troublingly, a rocket grenade launcher. Most of the time we do not give any credit to the brave men and women of our law enforcement and I think we need a rethink on this attitude. This is why we have taken out time today to honour them in appreciation of their acts of gallantry. Sadly, we have also lost a total of 124 policemen in encounters with armed robbers between January 2007 and September 2011. We should honour their memory by pledging more support for their comrades in arms for in spite of the dangers, these security personnel have continued to respond to distress calls once they are alerted.


We must also salute the cooperation of the various security agency commanders in Lagos, members of the State Security Council, men with whom it is a pleasure and privilege to work in striving to ensure a measure of peace and security in Lagos State.

Lagos is an international border state, a coastal port city, densely urban in nature, partly surrounded by waterways and home to about 18 million people who are largely multicultural. A relatively small land mass, Lagos has the highest state population in Nigeria. These factors make the state the economic hub of Nigeria but this enviable status is accompanied by peculiar challenges which stretch the infrastructural and social amenities and present peculiar law enforcement and security challenges in the state.

The inability of the Federal government to adequately

perform its function in terms of the provision of security and other facilities such as electricity and quality highways increases our vulnerability to criminal activities and it behooves us to take action in our own interest. More so, the Federal Government has continued to refuse to recognize the special circumstance of Lagos in order to provide a specific security response and infrastructure for the state.

As it stands today, the Lagos State Security Trust Fund model remains the only alternative to providing any form of succour to our people, more so with a federal government distracted by threats to national security, and while we pray that someday the much touted Police Reforms will be implemented in a manner that actually impacts on our day-to-day lives, it is at present the only method by which we can positively influence our own security circumstances. The model gives us flexibility and a measure of ownership and a legitimate demand for a measure of accountability from those charged by the constitution and deployed by the central government to protect us.

The challenges of security and law enforcement are a growing threat all across the world. The world is increasingly plagued by ideological, religious, environmental and economic challenges, and the countries like the US, Britain, Greece, and Italy which used to act as shock absorbers. receiving millions of immigrants and contributing to world prosperity are now themselves facing grave economic and social problems. These challenges are even more serious in 3rd World countries such as ours. We have seen many manufacturing industries relocate from Nigeria because of the crisis in the power sector. The instability in the financial sector has further compounded the problem with a lot of companies laying off employees as a cost adjustment measure. This has increased unemployment which has dire consequences including a direct impact on security of lives and property. More people are willing to take the risk of confronting authority even if at the cost of their lives and we must be prepared. Today we are witnessing the new and dreadful phenomenon of terrorism in its most virulent form followed closely by piracy off the national coast. And we must not fall into a state of denial that we are completely insulated. My philosophy has always been to hope for the best while preparing for the worst.

Rising insecurity in nearby states, especially bank robberies in which many lives are lost, further worsened by agitations of several disgruntled groups have made an already challenging situation more complex to solve. Kidnapping presents an additional security challenge, though I must state again that the response of our gallant policemen to

this challenge in Lagos State has been exemplary and has acted as a strong deterrent.

Ladies and Gentlemen, Lagos cannot operate in isolation not can it avoid being affected with some of the effects of the precarious situation all over Nigeria. It is too big and too vibrant and presents numerous opportunities to the criminal fraternity. The fact that despite all these issues we have been able to provide a widely acknowledged credible response and have continued to maintain order in the city is in due in large measure to this synergy we have developed.

In Lagos, we are solution oriented in our approach to security and other matters. This means that as we face new challenges, as is indicated by events around the country and in Lagos here also, we continuously review our responses. For example upon the realization that the police was in desperate need of trained drivers and on the advice of the Lagos State Security Trust Fund, I requested the IG to permit us employ 300 drivers as SPY Policemen which he graciously did. The Lagos State Government and the Lagos State Security Trust Fund was financially responsible for their specialist training at the Police College, Lagos which included offensive and defensive driving and other police skills. This process has not only ensured that the police are able to respond faster as these drivers have local knowledge, but that our vehicles would last longer because these men are professional drivers. These drivers are from here, they have a sense of belonging and they cannot be arbitrarily transferred out of the state as is the custom under the federal "common services" method. Significantly also, the scheme has provided uplifting jobs for 300 young people. Also, in order to check street robberies the Fund was involved in the establishment of the Special Motorcycle Response Squad to ensure that the people of Lagos State are safe as they commute around the city. The motorcycle squad has been very effective and we need to grow the squad.

In addition and in response to my further request, the Inspector General of Police approved the creation of 5

additional Area Commands, 5 new divisional police stations and a special command for the Marine Police in Lagos State and the State Government has undertaken to provide the infrastructure required for their operations including building the commands and equipping them. This was in response to the increasing expansion of settlements and the need for closer command and control in these areas. For instance, far away Epe was under Area A, Lion Building in Lagos Island while Ikorodu was under Area G. Ogudu. These new area commands have commenced operations from temporary sites while we have provided the land for the permanent sites and work has began for the construction of office blocks and other facilities. Lagos State has already provided 10 patrol vehicles for these new commands. This is the reality of the so-called federal system we run today...the states are compelled to subsidise federal functions even though the federal government keeps the bulk of national revenue. No matter, we have no choice and that is why I again call on you to contribute to this very demanding process.

The importance of effective and well resourced security agencies is the first principal of functioning societies. Under my direction, in the last one year, security agencies in the state have carried out several joints raids to dislodge dangerous criminals from their dens without drawing the attention of the 'public. The security agencies have been able to nip in the bud a number of potential ethnic and religious incidents before they degenerate because of the emergency call service that serves as an early warning system and the availability of work tools. And the most potent weapons are their speed in getting to the potential trouble spot, their number and equipment and their ability to engage without force and bring peace. Their presence, number and obvious preparedness often is enough to do the trick.

Ladies and gentlemen, together the Lagos State government has again in 2011 invested tax payers' money in our collective security, the details of which you heard in the report of the Board of Trustees, in demonstration of our commitment to improving security in our state and I assure you that we remain resolute in our resolve to ensure a more secure Lagos.

Clearly a lot has been done over the past four years and we are certainly far ahead of where we were in 2007 but it is a well know fact that security is the single most expensive human endeavor the world over. The various security agencies have outlined their challenges which include





constant patrol fleet increase and replacement, provision of more body armour (bulletproof vests, ballistic helmets and riot gear), increased number of motorcycles, walkietalkies, base radios, uniforms, radio towers and repeater stations and other sundry security equipment.

We must therefore ensure that our gains are not lost. We must look for better strategies to enhance our safety. We must once again tackle our problem headlong by contributing generously to the Fund.

This is the only way and I urge you to partner with the Fund to ensure a safer Lagos.



REPORT OF THE BOARD OF TRUSTEES



Introduction

The yearly Town Hall Meeting on Security with His Excellency the Governor of Lagos State, Babatunde Raji Fashola is an annual event during which the Governor and the Lagos State Security Trust Fund engage with stakeholders and donors over general security concerns, especially those involving violent crime and public safety. In addition, the Trust Fund gives account of its activities over the previous year and presents its audit report. The occasion provides an opportunity for the Commissioner of Police and other service commanders involved in the protection of lives and property to brief stakeholders on the current state of security and challenges and listen to their comments and concerns. Donors and those yet to donate to the trust fund are then called upon to commit further assets to the Fund in the interest of sustaining the security model improving the security situation.

The Lagos State Security Trust Fund was established in 2007 by a law of the Lagos State House of Assembly to raise and coordinate the application of donations in cash and equipment from government, private organisations and individuals which are urgently required to enhance the operational capacity of the police and other security agencies which have suffered from years of federal neglect and underfunding, so as to improve their effectiveness. Due to the efforts of the Fund and its partners it has been able to transfer assets to the police and the various security agencies at a rate and volume unprecedented in any state in Nigeria. Just to recap, since the establishment of the Fund in late 2007 it has been able to transfer a total of 561 patrol vehicles, 124 high speed motorbikes and 350 protective rider kits, 30 APCs (armoured personnel carriers), 2 helicopters, 455 walkie-talkies, 654 base radios (for patrol vehicles and police stations), 1680 ballistic helmets, 1760 bulletproof vests (and 250 replacement vests), 840 tires, 220 batteries, 5 generators, 1500 each of rain coats and police standard boots, 5 patrol boats, 2290 sets of uniforms, 100 gunshot trauma packs, 1000 AK 47 rifles and 2,000,000 rounds of ammunition, and the repair replacement of radio towers/repeaters.

The need to properly account for the donations

received, and, to ensure the maintenance of these assets in order to guarantee sustainability/continuity were at the forefront of considerations in establishing the Fund. Indeed, this year the Fund has expended N25,581,685.00 on the repair and maintenance of vehicles and APCs, including replacement of tires and batteries for various formations including the RRS, the Prisons Service and OP Mesa. It is important to note that the Fund has in time come to provide the hitherto missing management and maintenance component vital to the sustenance of any security system. The Fund is managed by a Board of Trustees with an Executive Secretary as CEO. The Fund and indeed Lagosians generally have been fortunate to have a Board that is very well led and which has an unquestioning commitment to

The Fund and indeed Lagosians generally have been fortunate to have a Board that is very well led and which has an unquestioning commitment to accountability and effective management. No expenditure is incurred without the approval of the Board and all such expenditure is fully documented, and no equipment is purchased for or released to the security agencies without (1) a specific request from an agency; and (2) without the agency justifying to the Board the basis of the need and its relevance to the challenges on the ground. In terms of administrative costs, the Fund has adopted a philosophy of

lean management, with administrative costs generally involving less than 5% of total expenditure including rent and allowances. This year the percentage is 4.24%.

From time to time, the Board invites the Commissioner of Police and other commanders to attend its meetings and brief members with a view to better understanding the state, challenges and demands of the security situation.

Composition of the Board of Trustees

The Board of Trustees was reconstituted in 2011 by the appointment first by HE the Governor of three Board members, specifically: Mr. Opeyemi Agbaje, MD, resources and Trust Company Ltd. replacing Dr. Reuben Abati, and Mr. Biyi Mabadeje and Mr. Gbolahan Lawal, Honourable Commissioners of Science & Technology and Agriculture & Co-operatives respectively, replacing Messrs. Lanre Balogun and Jide Sanwoolu, former commissioners of Rural Development and Establishment & Training. We were also very gratified to welcome an additional Board member appointed by His Excellency in the person of Mr. Bisi Onasanya, GMD of First Bank Plc. representing the Bank and which, of course, brings our Bank membership on the Board to three along with Skye and Zenith Banks, represented by Mr. Kehinde Durosinmi-Etti, GMD, Skye Bank Plc., and Mr. Ebenezer Onyeagwu, ED zenith Bank. Since the term of the pioneer Board came to a close on 7th October 2011, HE the Governor formally re-inaugurated the Board with Mr. Remi Makanjuola retaining his Chairmanship and with DIG Olusegun Kassim also staying on as our mentor-member. In essence, we have been able to maintain a measure of continuity which is very important for developing institutional memory and informed decision making.


The law enjoins the Fund to appoint an external auditor and publish the audit reports each year. In line with this statutory requirement and the Fund's philosophy of accountability, the well-known audit firm, PriceWaterHouseCoopers was appointed in 2008 and has audited the Fund's accounts since then. The audit report for 2010 is contained in the brochure.

December 2010 to November 2011

The Fund received a total of N199,090,000.00 in cash since the November 2010 Town Hall Meeting, approximately N1,004,280,109.00 in equipment and fuelling of patrol vehicles from the Lagos State Government, and N91,000,000 in cash value of donations of equipment from the private sector. The list of donors and the specifics of each donation is contained in the brochure. Clearly, the Lagos State Government remains the main contributor to the Fund, and though the private donations are much appreciated, it is manifestly clear that more is required in terms of support from companies and individuals yet to contribute. As it stands, the current donors, most of whom are year-on-year contributors are effectively subsidising security for the rest of us.

Significantly, because of the continuous needs of the security situation, we expended more than we received, a total 2011 expenditure (subject to audit) of N249,302,286.96 as against a cash income of N199,090,000.00 as indicated earlier. Because of this high outgoing, we end the year with a net balance of N53,260,000.00 as against a sum of N181,393,723.00 which was the balance at the end of last year. This again underscores the challenges of retaining our viability as an effective intervention agency in providing support for our law enforcement partners.

But we must acknowledge the fact that we have been lucky to at least expand our donor base with the coming on board of the Nigeria Ports Authority who have committed



N6.6million every two months for the fuelling and maintenance of the six gun boats launched by the IG in April this year, the commitment by CocaCola Plc to include donations to the Fund in its 2012 budget, the recent installation of emergency phones connected to the 767/112 emergency call center on the Third Mainland Bridge by MTN, and the growing number of churches, unions, associations, individuals and schools and school children who contribute their widows mite. These are much appreciated and encouraging.


Activities of the Fund 2011

In spite of the limitations due to receiving less donations than expected, the Fund was still able to respond to security needs in a fairly substantial manner. In addition to our regular investment in maintenance Trust Fund of assets and repair of agency assets on special dispensation, the Fund this year decided, on the request of the police and the State Security Council, to pursue a policy of build-up of divisional police capacity across the state. Following on this philosophy, the Fund acquired or had donated to it sufficient vehicles to supply many divisions and formations in various parts of the state which did not have sufficient or functioning vehicles and thereby enhance cross-state policing capacity. Thus we distributed vehicles to the following police stations and formations: Federal Special Anti Robbery Squad, Adeniji Adele (4); Lagos State Police Command Special Anti-Robbery Squad (5); Lagos State Command Special Ops Attack Squad (4); Adekunle Division (1); Sabo Division (1); Bode Thomas Division (1); Agbado Division (1); Gowon Estate Division (1); Ilupeju Division (1); New Oko-Oba Division (1); Alakuko Division (1); Ijaye Ojokoro Division (1); Ikoyi Division (1); Maroko Division (1); and Mopol 49. Epe. These were in addition to vehicles we handed over to OP Mesa, the SSS, Lekki Convoy Patrol, and the Lagos State Task Force on Environmental Enforcement. But there are still many needs especially with the creation of five new Area Commands, five new police divisions and a special marine police command, and with the federal government shifting the burden of both constructing and equipping them onto the state government's already heavily burdened shoulders. These Area Commands are vital strengthening elements of the Lagos State security architecture, especially in terms of bringing command and control closer to their geographical areas of coverage, but we need help in making them truly effective and functional. The Lagos State Government has already donated vehicles and communications equipment for their start-up and is to

undertake the construction of the various command headquarters in 2012. At the moment they are operating out of temporary quarters either donated by the various communities or sharing government buildings. We need to move on this issue very quickly. In addition and as is its custom, the Lagos State government beefed up RRS capacity in 2011 by donating 100 fully equipped Ford Ranger Patrol Vans, 84 high powered motorcycles for the special RRS motorbike squad, 200 bulletproof vests, and 10 additional APCs to the police through the Trust Fund.

What the Trust Fund with the support of the Lagos State Government and our donors has been able to do to some





substantial degree is to give the police and other security agencies flexibility in dealing with the challenges that face us especially in the areas of violent crime, public disorder and surveillance. So in effect, a discernable security system is taking shape. The Trust Fund is able, for instance, to invest in the development and deployment of the special motorcycle patrols, a truly home grown strategy, which, from reports, we have found to be a veritable evolving solution to some of the peculiar challenges of policing a place as dense and traffic challenged as Lagos with the additional issue for instance, of areas like Apapa where long delayed federal road repair work and the thousands of tankers/trailers attracted to the port to lift fuel have created monumental problems. There are many recorded instances where these patrols have more than proved their worth in trying situations and their mobility and presence has given citizens a sense of comfort and assurance that somebody somewhere is looking out for them. The policy was developed locally by the state government and the Fund working with the police authorities because we could identify local peculiarities and address them without waiting for the center. It is doubtful that such an initiative could have developed under the old system. We need to grow this model with your help. The ideal scenario is to have enough motorbikes and trained and well-kitted men so that we can deploy the special motorbike squads across the whole state. The patrol vehicles enable more mobility and coverage of larger areas, the presence of the APCs mean that the men can face serious threats well protected and they also act as a major deterrent to attacks on banks and other financial and commercial institutions by heavily armed gangs, the radios mean that communication has improved and the emergency call center means that the police are more quickly able to intervene and respond to distress calls with citizens' input. The helicopter patrols also allow the operatives to have a birds' eye view of your city.

Training investments

The Fund also invests in support of the state government on capacity building and training, which is one of its statutory functions. On realising that there was a major lack of trained drivers within the Rapid Response Squad, on the Fund's advice (and advising the governor is also one of our statutory functions) HE Governor Fashola made a case to the Inspector General for the training of SPY police men as drivers and their integration into the RRS and he kindly approved the training and integration of 300 men and women who would be recruited locally and be effectively

employees of the LASG, but working with the police. The 300 SPY police were trained at the police college in police driving tactics, handling of APCs and other skills at a cost jointly borne by the state government and the Fund, and have now joined the RRS, strengthening their capacity and bringing local knowledge of the environment and the on board with them. This unique and unprecedented initiative also has the advantage of ensuring that these skilled individuals are not transferred to other states along with their value-added training as is the normal practise of the federal government's "common services" structure.

Current Challenges

As stated earlier, the most pressing challenge of the Fund is sustainability and growth over the long term. The prospects of any viable alternative to the Fund, or a reduction in security threats at the present time, either by way of full (or matching) investment by the federal government in the security of the state and its citizens generally (as against investment in the protection of federal government installations/facilities), or by criminals and terrorists suddenly turning a new leaf and becoming model citizens, is highly unlikely. Recent reports in the press show a rising wave of violent crime across the country, even not taking into account the threat of terrorism. As the army/JTF moves into certain states to counter these terrorist threats, the ideologues may stay on to engage them but the career criminals will move to other states. Our best bet in providing us with a level of local protection is to support the security agencies through the instrumentality of the Fund. It is your institution, accountable to you and working for you. The officers and men of the various agencies are good at what they do but they need support. When the Governor chairs the monthly State Security Council meeting and analysis is done and strategies developed, it is the tools provided mainly by the state government and the Fund that enable them to put these strategies into effect. And let us not think that we are not affected by happenings in other parts of Nigeria. We are and Lagos, the heart beat of the nation is a potential target. We must be prepared not just for the moment but into the future. We need to sustain and then grow our model so that we are assured of adequate capacity for any eventuality. There will always be crime, it is a business, a fact of modern living; and Lagos is complex, challenged and potentially vulnerable, but we can reduce the window of opportunity to a tiny hole that can be managed. This is what your partnering with the Trust Fund over the years has enabled the police and her partners to do. Imagine if we took all of the items I have mentioned out of the security equation! Imagine if we just let them depreciate!

Anyone involved in security will tell you: the rate of attrition on items, kits, uniforms, equipment, vehicles and men is extremely high especially in this steamy tropical climate. The only solution is to have a properly defined and properly resourced support strategy that maintains and replaces and adds capacity to the system where the need arises. And these needs are constant and that makes the process extremely expensive though delivering good value.

Conclusion

In concluding, let me inform this respected House, as I did last year, that the Lagos State Security Trust Fund model was discussed and endorsed as a viable model for local support of security agencies at the full plenary of the 12th United Nations Congress on Crime Prevention and Criminal Justice held in Salvador de Bahia, Brazil in 2010. And since the last Town Hall Meeting seven states have approached the Fund for consultancy/advice on setting up their own security trust funds and three states have actually established such funds. This underscores the fact that there is a general acknowledgement that for now, states and their citizens will have to make some sacrifices if they are going to expect effective security responses from the men of the

security agencies. I therefore, while thanking those companies and agencies and individuals who have consistently supported the Fund over the past four years, appeal to those yet to invest to do so. It is a noble cause to invest in the general safety of the citizens, especially those, in the majority who have no recourse to VIP guards and convoys, though truth be said, if such people are faced with real danger it is doubtful if those VIP guards will lay down their lives for them. On the other hand, many police offices and military men have lain down their lives over the years in defence of the ordinary citizen. Please support them. It is through this support that we can improve our general quality of life and create what is the ultimate definition of security, "the relative absence of fear".

Report on the financial statements

STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES



(a) Basis of preparation

The financial statements are prepared on a modified cash basis under the historical cost convention and in accordance with applicable standards.

(b) Revenue recognition

Cash donations are recognised as revenue when cash is received or when pledges are certain to be redeemed.

Donations in kind are valued at market value or reasonable estimates

(c) Property, plant and equipment

Property, plant and equipment are shown at acquisition cost less accumulated depreciation. Acquisition cost represents the purchase price of the item plus freight, insurance and handling charges, or the fair market value for donated items.

(d) Depreciation

Depreciation is calculated on the straight line method to write off the cost of each asset to their residual values over their estimated useful lives, at the following annual rates:

Office furniture and equipment 25
Computer equipment 33
Motor vehicle 25

(e) Expenses

All expenses are accounted for when incurred or obligated, whether or not cash has been paid, and have been classified under headings that aggregate all costs of similar nature. Expenditure is recognised:

- when goods or services are received
- when cash is paid in advance to project contractors

(f) Investments

Investments comprise term deposits placed with banks and are stated at the lower of cost or net realisable value.

(g) Inventories

Inventories consist of items received from donors, not yet distributed to approved security agencies.

(h) Accounts receivable

Accounts receivable consist of pledges made by donors which have not been redeemed at year end.

These are stated after deduction of specific provisions made for pledges considered doubtful of recovery.



1 The Fund

The Lagos State Security Trust Fund was established in 2007 under the Lagos State Act 2007. The objectives of the Trust Fund are to raise money through voluntary subscriptions and donations from all interested Government agencies, private organizations and individuals. The money thus raised is to be used for the acquisition and deployment of security equipment and such human, material and financial resources as shall be found necessary for the effective functioning of all Federal, State and Local Government and other security agencies operating in the State and part of the fund shall be reserved for the training and retraining of the security personnel.

PROTOCOL!!!

INTRODUCTION

It is with a great sense of delight and excitement I stand before you all today to deliver a report on the activities of the Lagos State Police Command from October, 2010 to September, 2011. My excitement stems from the privilege of working with a Governor who has a strong passion to fight crime head-on. He has not only provided the enabling environment for officers and men of the command to discharge their responsibilities effectively, he has continued to provide a steady stream of the necessary logistics and moral support for optimum service delivery. The establishment of the Lagos State Security Trust Fund(LSSTF) in 2008 has proved to be a master stroke in providing a veritable platform for governmental support for police effort.

The novel synergy has resulted in the current national and international opinion that Lagos State has taken the lead in the combat of crime and the provision of crime fighting infrastructure worthy of emulation by others.

Lagos as a mega-city and the economic hub of Nigeria and the Sub-Saharan Africa, quarters all but one of bank headquarters, the largest sea and air ports in the country, Diplomatic Missions and Consulates. Nesting along side these institutions are a myriad of public utilities, corporate organizations, media houses and a host of others. Consequently, this has swelled the population of the state. There is no gainsaying the fact that Lagos is a mini-Nigeria with a sprinkle of all the ethnic groups, including a sizeable portion of expatriates that are resident in Nigeria.

The special position of Lagos in the socio-economic and political landscape of Nigeria as highlighted above has placed enormous responsibilities and security challenges at the doorsteps of the command. The allure of city life has triggered a strong rural-urban drift, with many fortune seekers, who sometimes end up as criminals, finding their way to Lagos on daily basis. A new twist has just been added to this: a sudden upsurge has been observed in the large number of illegal immigrants from the neighbouring West African State of Chad, Niger, Mali, Bourkina-Faso etc, who now

throng to Lagos to seek for greener pastures. As funny and incredible as it may seem, these men possess no certificates, skills and other relevant prerequisites that will render them employable. Besides, there is virtually nothing known about these individuals. This of course gives cause for worry: as they undoubtedly become ready tools for criminal activities.

Though, Lagos as a mega city is expected to have a high level of crime rate like any other mega city in the world, like robbery, murder, fraud, car robbery, bank robbery, trans-border crimes and of recent kidnapping, the reverse is manifestly the case in Lagos. This did not come as a surprise. The novel approach of the Lagos State Government to set up a Security Trust Fund as a means of bolstering security in the state through capacity building has immensely impacted on security of lives and property in the state. I therefore call on the citizens of Lagos to continue to support the Fund and I pledge that the officers and men of the police force would do all within their power to justify your support and trust in carrying out our constitutional duties of protection of lives and property.

From available records, the command could hardly boast of ten serviceable vehicles prior to the advent of the Trust Fund. But today, the story is different; the command through the effort of the Trust Fund, is now the proud recipient of sundry logistics and financial assistance which has immensely boosted the capacity of the men to perform their duties. Items so far received in this regard include but not limited to the following:-

- 1. Two(2) Helicopters;
- li. Thirty(30) Armoured Personnel Carriers(APC)
- lii. Three Hundred(300) Patrol Vehicles including mobile workshop vehicles;
- Iv. Five(5) W-19 Fibre Boats fitted with double 75HP Outboard Engines
- V. One Hundred(100) Ballistic Helmets;
- Vi. One Thousand(1,000) AK-47 Rifles;
- Vii. Two Million(2,000,000) 7.62MM Calibre Ammunition;





viii. Sixty(60) Patrol Motorcycles;

ix. Three Hundred (300) Walkie Talkies

On the first day of my assumption of duty as the Commissioner of Police Lagos State, one hundred patrol vehicles and fifty motor cycles were donated to fight crime in the state. It is gratifying to note that our mission to reduce crime to the barest minimum has been made easy by this unparallel support by the state government. Just a month ago, His Excellency, the Executive Governor of Lagos State, Mr. Babatunde Raji Fashola(SAN) donated yet again ten(10) units Armoured Personnel Carriers(APC), fifty(50) vehicles comprising patrol vehicles and mobile workshop vehicles, one hundred(100) walkie talkies and two hundred(200) bullet proof vests through the instrument of the Lagos State Security Trust Fund(LSSTF) to the Police which has been added to the figure presented above.

Within the last few months, crime have not only been prevented, but have been cracked or nipped in the bud when committed. This is due to the quick response to distress calls and the scrupulous and diligent use of information volunteered by members of the public and tools at the disposal of the police to do the job. To highlight a few, On October 8, 2011 about 1200 hours, Commander PMF 2 Keffi SP Patrick Ejedawe who acted on a tip-off led a team of policemen who stormed the hideout of armed robbers/kidnappers at 15/16 Ebute Kekere Afolabi Street, Igando. The hoodlums had kidnapped one Rodney Ogbada 'm', Belinda Oke 'f', Mr. Godwin Nwanneka Egiofor Okonkwo 'm' and Dr. Godwin Emeka Ene 'm' and demanded for a ransom of One Hundred and Fifty Million Naira(N150,000:00k) as condition for their release. Arrested at the hideout are Kenneth Okoronkwo 'm', 29 years old of Arochukwu, Abia State and Azubike Okoronkwo 'm', 30 years old of Umunoke Village, Awka, Anambra State while their leader, Godwin David 'm', 34 years old of Otankpa Village, Isiukwu-Ato, Abia State was arrested following discreet investigation. Items recovered are:-

- (I) One rocket launcher;
- (ii) Three rockets;

- (iii) Eight AK-47 rifles;
- (iv) One hundred and eight AK-47 magazines
- (v) Fourthousand and seventy-four (4,074) 7.62mm caliber ammunition;
- (vi) Two pairs of locally made handcuffs;
- (vii) The sum of three million naira allegedly paid as
- (viii) One Nissan Xterra Jeep Reg. No. RN-138-AAA
- (ix) One Ford Explorer Jeep with Reg. No. BV-194-EPE
- (x) Two cutlasses;
- (xi) Fourtelephone handsets;
- (xii) One Tiger generating set;
- (xiii) One Stabilizer;
- (xiv) One standing fan;
- (xv) Assorted charms and
- (xvi) Two vehicle number plates EQ-815-BEN and CW-815-RBC
- (xvii) One Nigerian Navy Identity Card bearing the name of Obinna with MNR/NIG.702/0467 shipping third engineer,
- (xviii) One pair of Navy uniform belonging to Obinna and one Navy car sticker.

In another development, on August 27, 2011 about 0200 hours, a Police Patrol team exchanged gunfire with armed robbers in a Toyota Sienna Bus Reg. No. BV-785 KUJ at Kuramo close to Bar-Beach, Victoria Island. Two of the armed robbers died of bullet wounds while others escaped. The following items were recovered from the robbers:-

- (i) Four AK-47 rifles Nos. 3531154, H98780, A51628 and 14500049;
- (ii) Twenty-Three AK-47 rifle Magazines;
- (iii) Two Hundred and Twenty-Five (225) Rounds of 7. 62MM calibre live ammunition and
- (iv) Aforesaid bus

Also, on August 21, 2011 about 1230hrs a Police team on stop and search duty at Fola-Agoro Street, Shomolu had an encounter with some armed robbers that attempted to snatch a Honda CRV Jeep with Reg. No. DF-464-MUS from its owner. After a gun duel with the Police however,





five of the armed robbers were shot dead while others escaped with bullet wounds. Items recovered were:-

- (i) One Beretta pistol;
- (ii) One double barrel shot gun cut to size;
- (iii) Two locally made pistols;
- (iv) One motorcycle and
- (v) Eight live cartridges.

Similarly, on 24/05/2011 about 0900 hours, Special Anti-Robbery Squad Ikeja that acted on a tip-off arrested one Israel Ubatuegwu'm' with a stolen Toyota Corolla saloon car with registration number MR-595-AAA. The suspect led the team to his hideout at Udu Moses Close, Lape Phase 2 Lekki where other stolen vehicles were recovered. They are:-

- (i) Four Toyota Hiace Buses with registration numbers XB-251-THE, FC-351-LSR, CX-687-FST and FU-456-LSR;
- (ii) Two Toyota Corolla saloon cars with registration numbers EE-278-SMK and FB-695-LSR and
- (iii) Two unregistered Toyota Camry saloon cars.

Further investigation led to the arrest of two more suspects namely; Bolaji Owolabi 'm' and Festus Ehis Aghatise 'm' and the recovery of yet the following vehicles:-

- (i)Twelve Toyota Corolla Saloon Cars Reg. Nos. BQ-169-EPE, BR-91-EPE, BT-244-BDG, BT-207-EPE, BP-657-EPE, BU-256-EPE, BU-884-EPE, BU-245-EPE, FM-426-LSR, DE-195-APP, Two unregistered;
- (li) Five Toyota Camry Saloon cars Reg. Nos. FS-443-LND, EL-272-GGE, FB-735-KRDE, BP-658-EPE, BK-486-KWL
- (iii) One Honda Element Jeep Reg. No. JE-392-EKY

Another breakthrough that the Police had was on 24/07/2011, when a gang of Automated Teller Machine(ATM) robbers, having as members service

personnel, were arrested. They include Sgt. Onyeka Eboma, Omoloye Ezekiel, Sunday Gabriel, Atoki Oluwasola and Gambo Freeman. The sixth member of the gang named Cpl. Folorunsho Victor is still at large. Items recovered from them are:

(i) One Beretta Pistol No. AO6995Z with sixteen

rounds of .9mm caliber ammunition;

- (ii) One K2 Rifle No. 23469 with forty rounds of 5.56mm caliber ammunition;
- (iii) Two K2 Magazines;
- (iv) One Nissan Xterra Jeep Reg. No. CB-498-FST;
- (v) One Faragon Bus Reg. No. XB-401-KRD;
- (vi) One Gas Cyllinder;
- (vii) One Welding Machine and
- (viii) One Face Mask.

Yet again, Police foiled a bank robbery attempt on 02/10/2011 about 2130 hours at Zenith Bank Plc, Trinity Bus-Stop along Apapa-Oshodi Expressway. Marcel Agbono 'm' and Julius Osai 'm' were arrested in the act. Items recovered at the scene include:

- (i) One Iron Cutter:
- (ii) Two Gas Cylinders and
- (iii) Three Sledge Hammers.

These are just a few in a string of breakthrough theCommand has recorded against hoodlums, who now find the state unviable




















Operation MESA (OP MESA) is the code name of the special security outfit of the Nigerian Military (the Army, Navy and Air Force) that provides support to the police in the maintenance of law and order and the protection of government installations in Lagos State. Its operations are in accordance with the provisions of Section 217 of the 1999 Constitution which empowers the armed forces to support civil authority in the maintenance of law and order of the Federal Republic of Nigeria on the order of the President and Commander in Chief of the Armed Forces. This joint force is currently involved in internal security operations in 27 States of the federation.

The 9 Brigade Division of the Nigerian Army coordinates the activities of OP MESA are in Lagos State by while the Lagos State Government and the Lagos State Security Trust Fund provide the required operational assets and other logistics including ration allowance for the men of the operation. The focus of the outfit is to provide support/assistance to the police in the enforcement of Law and Order.

Mode of Operations

OP MESA though a joint force, operates as independent components (i.e the Army, Air Force and Navy). The outfit operates 24 hour daily patrols which involve both mobile and static patrols covering predetermined bits and government installations such as NNPC pipelines, loading stations, PHCN installations, oil companies, waterways, commercial hubs, tank farms and other government buildings/infrastructure. The patrols also cover black spots, areas of potential ethnic and religious conflicts and areas of critical need especially where military knowledge is required. The outfit also provides support to the police in cases of robbery and civil disturbance.

The activities of OP MESA are coordinated by the State Security Council which is chaired by His Excellency, the Governor. At council, several strategies are developed which ensure the synergy and effectiveness of the operations OP MESA.

REPORT ON THE ACTIVITIES OF OP MESA



Areas of Responsibility

Army Ikoyi, Mile 2, Badagry, Ikeja, Ogba, Ojo, Ikorodu, Mile 12, Ajah, Lagos Island,

Idi-Araba, Agbara and oil pipelines in the state.

Navy waterways and Oil pipelines in Lagos State and also Apapa, Ijora, Ajegunle and some areas of Mile 2.

Air Force - Ikeja, Mushin, Isolo, , Apapa Ijaye, Oshodi, and Alimosho including Ikotun, Egbeda, Shasha and its environs

The Strength/Capacity

Army 15 officers, 150 soldiers and 19 patrol vehicles Air Force 12 office, 120 men and 9 patrol vehicles. Navy 8 officers, 40 men and 8 Vehicles

The Effectiveness

OP MESA has continued to complement the police in its constitutional mandate of maintaining law and order. Its activities have enhanced security in the state by establishing security presence in areas that otherwise would have bear. Their military skill is often required for some specific incidents. They have been involved in the arrest of armed robbers, impersonators, fraudsters, hoodlums and other persons who breach the public peace.

In the last one year, OP MESA made over 700 arrests of armed miscreants, 93 armed robbery suspects, 8 suspected kidnappers and responded to about 60

incidents of civil disturbance. Their continued visible patrols also serve as a deterrent to criminal activity. Their operations have also assisted in ensuring enforcement of government policies on public order especially at places like Oshodi, Mushin and various motor parks within the state.

The analysis of the outfit's reports show that it has been very functional in foiling robberies especially home invasions, and preventing collapse of law and order. The outfit has also been involved in rescuing victims of accidents and crowd control.

The Challenges/going forward

As with other security agencies, OP MESA requires fleet replacement as the vehicles are involved in 24 hour daily patrols and most of them were provided about 3 year ago. In addition, the outfit requires adequate kitting of its men (ballistic vests and helmets), walkie talkies, base radios and other communication equipment, specialized tools such as night vision goggles and binoculars, and training.

It is necessary to further leverage on the existing cooperation by way of intelligence and information sharing amongst the various arms of the outfit and other security agencies in order to ensure improved security. As the state continues to expand in terms of infrastructure and population it is critical to provide support for the operations of OP MESA as a key component of security network in the Lagos State.
