## CHAIRMAN'S WELCOME ADDRESS

**Your Excellencies,  
Distinguished Ladies And Gentlemen**

Let me first of all welcome you to the 6th Annual Town Hall Meeting on Security with the very appropriate theme of "Growing our Investments in Security". It is indeed gratifying to note that we have maintained your commitment and interest over the five year period we have been in operation, as indicated by your presence here today.

Myself, and the members of the Board and management of the Lagos State Security Trust Fund are proud to have been part of this unique and long-lasting partnership of the collectivization of efforts at improving safety and security.

Let me at this stage express the gratitude of the Fund and by extension, the government and citizens of Lagos State, to all the corporate entities, religious bodies, members of the informal sector, associations and individuals who have kept the operations of the Fund going this past year. You will hear the specific details from our executive secretary in his report, but each donation, a big corporate one or the donation of a private citizen who pays N10, 000 into our bank account, is as important as the other, because it signifies an across the board buy-in to our model that is highly valued, and that continues to inspire us.

Ladies and Gentlemen, we meet today during extremely challenging times, and as I indicated in my welcome address last year, the business of security is never ever completed.



There is always some new challenge especially in this part of the world. As our country grapples with the stern tests of terrorism and environmental dislocations along with the economic and social pressures of an expanding and very mobile population, the burden of law enforcement and protection of lives and property increases exponentially. This places a continuous and heavy burden on the men and women of our security forces and on their equipment.

We in Lagos cannot be completely insulated from the spill-over of these situations. Indeed, this past year has been a testing one, and that we have been able to contain the situation is largely due to the efforts of the state and local governments, the Nigerian Ports Au-

thority (the sole non-security federal agency that contributes to our efforts) and your good selves.

In terms of the long awaited improved input by the federal government in terms of funding of operational logistics, if only to match what we have been able to do, I regret to say that the situation remains largely unchanged from when I addressed you on this issue last year. If not for the continued commitment of the Lagos state government and the LGAs and your donations of cash and equipment it would be virtually impossible for us to face the current challenges, and hence the need for continuous growth of investments in security hardware.

Some of you may not be aware, but we receive requests for assistance from virtually every federal law enforcement and security agency operating in Lagos, even though yearly budgets are passed for their operations by the National Assembly. Our usual recipients are already very many – Zone 2, the Lagos State Police Command, the Special Anti-Robbery Squad, the over one hundred Area

Commands and Police Divisions, MOPOL, the Marine Police, the Counter-Terrorist Unit, the Prison service, the State Security Services, OP MESA (combined armed forces anti-crime units) and the army. This does not include support we provide for the Task Force on Environmental Offences and Neighbourhood Watch. But we have received requests also from the Railway Police, the NDLEA and the NCDSC.

Of course we have concentrated largely on the state police command with its various components including the RRS because we have to apply your Funds judiciously and we just do not have enough to go all round, but this gives a picture of just the kind of pressure we are under. And each of these agencies has a role to play in the security architecture.

And so, as we face up to these challenges and prepare for the coming year, we are compelled to rely once again on our collective spirit and enterprise to provide as much protection as we can for all our citizens, visitors and businesses.

As Lagos continues to expand as more and more people relocate and more and more businesses set up shop, we must be prepared to continue the resourcing and refreshing process we have set in motion. While I am confident that our very loyal year-on-year do-

nors will continue with their support, I make a heart-felt appeal to those yet to join us to do so urgently in the overall interest of our dear state. Once again, I thank you all for coming out today in support of the Security Trust Fund and in support of His Excellency the Governor's continuing and very personal passion for and involvement in the security, safety and law enforcement concerns of the citizens of Lagos state.

### Protocols, Distinguished Ladies And Gentlemen

**W**e started this journey five years ago and I am delighted to welcome you to the 6th consecutive Town Hall Meeting on Security.

While we should be proud that our partnership has continued to achieve its objectives in the face of current security challenges that

arise from current social and economic factors, it is necessary to reflect on what the situation was at the beginning of this journey, to better appreciate how far we have come. But indeed we meet again under challenging circumstances.

You will recall that before the establishment of the Lagos State Security Trust Fund, the Police and indeed other security agencies were almost crippled by the lack of basic tools to carry out their statutory responsibilities effectively. This made our state a fertile ground for criminal activity. Armed robbers ruled the streets even during the day, while night life was almost extinct.

Our resolve to repossess our State from these criminals led to the setting up of a Security Committee ably chaired by Alhaji Musiliu Smith, which was charged with the responsibility of proffering pragmatic solutions to the security challenges at the time.

Regrettably, the challenge of equipping and resourcing our security agencies in the face of the insufficient support from their principal, the Federal Government; has continued to this day.

It is now very memorable history that the Report of the Security Committee led to the setting up of the Lagos State Security Trust Fund in 2007, by a Law of the Lagos State House of Assembly; and with your contributions the Fund has continued to provide equipment and logistics for the police and other security agencies in Lagos State.

Together, we have provided through the Fund, equipment and logistics valued at N 8.7

billion for the Police and other security agencies in our dear state. I am sure you have seen these assets all over the State and I make bold to say we have provided over 85% of the assets currently in use by the security agencies in Lagos State. The Executive Secretary of the Fund has given us a very detailed report of the assets and activities of the Fund.

It is necessary to state here that when I say WE, I mean your State Government, Local Governments/LCDAs, private organizations, associations/groups and individuals including school children, who have continued to remain steadfast in their contributions to the Trust Fund.

*Our history, inclusiveness, liberal policies and location has made our state a mother state with a population of about 18 million people out of the country's 148 million.*

Our commitment and achievement has made our security model a standard for other States in the country.

Over the years, these assets have helped to improve the security of the State, especially the ability of the agencies to respond to situations in a way that they were quite simply unable to, in the past.

In addition, the improved security has attracted a lot of investment, both foreign and local. Hotels and internationally franchised fast food chains, chain stores, and cinemas are dotted all over Lagos. For the first time a Broadway show "FELA" was staged in Lagos, and also worthy of mention is recent visit by the Williams sisters (Venus and Serena), and the jazz super star George Benson, etc.

These would not have happened without the perception of improved security in Lagos State. They have all given our State very high international prominence and we must continue to protect that status. We still boast the only functional and effective dedicated

emergency call centre in Nigeria, that is the 767/112 emergency call centre which operates a 24 hour service. The call centre currently has 135 agents who run eight-hour shifts of 40 agents per shift.

Ladies and gentlemen, although some people still choose to sit on the fence, I wish to express my sincere appreciation to all those who have stood by us throughout the journey; especially those who have continued to contribute to the Fund yearly. Indeed we have achieved a lot especially when we consider where we started from, but our job is far from done.

Security is everybody's business. It is like oxygen. Where it is in great supply we tend to take it for granted. When the supply is threatened, it is the only thing that matters.

Our history, our inclusiveness, our liberal policies and our location have made Lagos State a mother state, with a population of over 20 million out of the country's estimated 160 million people.

We are also surrounded by neighbouring States that rely on our economy for their own

development. This advantage comes at a price.

The analyses of suspects arrested for criminal acts have revealed that majority of the crimes are committed by people from other parts of the country; non residents who come into Lagos to rob or kidnap and then flee back to their hideouts outside the State to share the loot and plot anew. A random sampling of crime investigation statistics for the months of July to September 2012 illustrates my point.

trates my point.

Of the 183 suspects arrested for the offences of robbery and kidnapping, the figures showed that 22 of the suspects were from Ogun State, 13 from Anambra, 9 from Oyo, 9 from Edo, 5 from Imo, 6 from Lagos, 4 each from Ondo and Delta, 2 each from Enugu, Abia and Ebonyi, and 1 each from Rivers, Osun, Kwara, Borno and Kogi States.

In recent times the role of Lagos as a mother state in Nigeria has again come to the fore, as a lot of people have relocated to Lagos to escape the effects of the spate of terrorist attacks in some parts of the country, as well as the rise of unprecedented environmental disasters (flooding and erosion) in some States in Nigeria.

Unfortunately, some of these refugees are of evil intent. Also, because of the intense activity of the JTF in some northern and south-south States, the ideologues have stayed to take them on but the professional criminals have moved, seeking softer targets. Our job is to see to it that we are not one of those softer targets.

The Federal Government has not helped matters by its seeming refusal to properly equip its agencies to wit: the Police and other federal security agencies. In spite of the talk of police reform over the past decade, nothing substantial appears to have been done beyond the rhetoric.

Also significant is the fact that there are a number of abandoned offices and houses all over Lagos resulting from the movement of federal agencies to Abuja. These buildings attract criminals and miscreants who use them as hideouts for planning criminal activities and sharing their ill-gotten loot. An example is a 17-storey building abandoned since the 70s by the Federal Government in the Okoko-maiko area of Badagry Expressway, which has become a hideout for criminals who terrorise the residents of the area.

The security agencies have conducted a number of joint raids on the property but as long as it remains standing and unutilised it will always attract criminal elements and remain a constant security issue.

It might interest you to learn that from the inception of the Fund till date, the Federal Government has not provided up to 30 patrol vehicles for the police in Lagos State. Whilst it is fair to acknowledge the receipt of 11 patrol boats, it bears stating that the Federal Government does not seem to think that the police require other equipment such as a sufficient number of APCs, walkie talkies, communication masts, repeater stations and motorbikes, even though security is constitutionally its exclusive preserve.

The criminals that unleashed terror on our dear state on Sunday the 9th of August 2012 came close to reminding us of the chaos that existed before the establishment of the Security Trust Fund. But unlike in the past, the police were able to confront them and tactically chase them out of the State in order to avoid the loss of innocent lives that is often the result of a full blown confrontation. The security agencies did not stop there; they traced them to their hideout, made arrests and recovered a large cache of arms and ammunition.

The arrested suspects are currently being prosecuted and we must commend the commitment and collaboration of the various security agencies for this.

Sadly, in the confrontation we lost two of our gallant policemen – Cpl Gift Obouwon and Spy/PC Ifonlaja Ayoola, whose memories are being honoured here today. Cpl Gift Obouwon was a gallant policeman and Spy/PC Ayoola was one of the Spy Police drivers recruited by us; a Lagos State citizen with local knowledge of the State who drove the team to confront the robbers in RRS patrol vehicle number 257. Their passion and dedication to duty is greatly admired and appreciated.

These are just two of the several other policemen who have lost their lives in the line of duty. Their lost lives are some of the real costs of security. They also underscore the need for us to properly kit our security agents to ensure as far as possible, their safety and effectiveness.

On November 11, 2012 there was another unfortunate attack on Regal Seaview Estate in the Lekki area. Without the APC's our men and officers would have been clearly suicidal to attempt to confront those criminals. But with our APC's the odds were tilted safely in our favour. Our men moved in and showed

the value of your investment. They repelled the robbers, made arrests and by persistent and unrelenting investigation they have broken the entire gang and arrested their arms supplier.

Also, a gang who broke into the house of one of our members in the State Executive Council has been rounded up.

While we continuously review our methods at our monthly security meetings to prevent crime, we sadly cannot stop all criminals from trying. But the clear message we are sending as I have repeatedly stated is that if you attack our citizens, we will relentlessly hunt you down, apprehend you and bring you to justice. We must also salute the courage of the men and women who put themselves in harm's way to protect us every day – the Police, the SSS, the Army, the Navy and the Air Force.

On behalf of the Government and People of Lagos State, I thank all of them for their dedication to duty; often in trying circumstances, to ensure that we are safe.

Although they have signed up to pay the supreme price, they should at least be given a chance against those that are out to harm us. And one good way to give them a chance is to provide these security operatives with the equipment/logistics they require to perform their statutory duties more effectively.

Although we have experienced seasonal spikes in reported cases of crime, I must assure you that they are not unusual in the season of the year that they happened. And they are not like anything that we experienced before, when this journey started, because we are in control and we are proactive.

The issue of the protection of public infrastructure is another challenge. For example, as we light up the city to improve security and



nightlife, one of the major challenges is the theft of cables. The BRT/LAGBUS buses are also usual targets of groups who claim to be aggrieved with government while some cut out the metal railings on our bridges to “produce” cutlery and other metal ware.

We will therefore require dedicated patrols to ensure that criminals do not sabotage our efforts towards security, social and economic growth and development. These are other areas that put pressure on our security apparatus.

Many of you have made massive investments in businesses, properties and so on. And your investment in our fund helps to secure your businesses and larger assets. So while I welcome and salute our traditional large donors, I must remind all of us that this is not their problem alone and your small donations, if that is what you can afford, will also help the cause.

At this point I wish to say that we are encouraged by the expansion of our donor base in the last one year as more private organizations and individuals have contributed to the Fund as indicated in the report by the Executive Secretary.

This growth indicates a better acceptance of our model and further validates our decision to face our issues head long. The security agencies need to replace some of their existing equipment and assets such as the initial fleet of RRS patrol vehicles and that of the divisions/area commands. They also require more modern gadgets such as car scanners, surveillance vehicles fitted with necessary surveillance equipment, etc that will assist in crime prevention.

Let me use this opportunity to appeal to all businesses and residents who can afford it, to install surveillance cameras outside their premises. They help in no small way in other jurisdictions to track down and apprehend criminals. I can imagine that some of you may be thinking, "How much do we really need?" Honestly, I can only answer that question by giving you an example.

We have over 9000 roads in Lagos State. If we put our patrol vehicles of approximately N5 million each to patrol every road, we would not have done anything extra-ordinary. But the cost of procuring 9000 vehicles alone is N 45 billion. If we put 20 litres of petrol per day at N97 per litre in each vehicle in spite of the fact that they are supposed to be on the road for 24 hours, each vehicle will require N1,940.00 per day; 9000 vehicles will require N17,460,000 per day and in 30 days it will be N523,800,000 or N6,285,600,000 per annum.

This is how big the elephant is. All I can say is that we should be optimistic and committed enough to tackle it one piece at a time.

Ladies and gentlemen, security is expensive and we are bound to make those sacrifices that will ensure our general security and safety.

In fact these donations should be seen more as investments in our collective security and experience has taught us that we enjoy far more advantages tackling the challenges to-

gether rather than doing it individually.

On our part as a Government, we will continue to lead by example by playing the leading role in this battle to secure our state by way of resource provision and direction. We are not afraid to take the tough decisions that will ensure a better and safer Lagos, as we have demonstrated with the passing of the Road Traffic Law. We will continue to do this in our collective interest.

Our overriding policy as a government is designed strategically along the lines of safety and security first, in order to promote social and economic growth and stability in Lagos State.

As I wish you a very merry Christmas and a prosperous 2013, I urge you all to remain safety and security conscious. We are leaving the rainy season and leaving behind the threat of flooding, but in doing so we are also approaching the dry season with its risk of fire incidents. We are prepared to respond, but we need you to be more careful and preventive in your dispositions in order to make it easy for us to keep you safe and secure.

We will remain resolute in our quest for greater security and we urge you all as worthy partners, not to relent in your contributions to our common cause.

## INTRODUCTION

### ESTABLISHMENT AND ROLE OF THE FUND

The Lagos State Security Trust Fund has been in existence since November 2007 when it was established by a law of the Lagos State House of Assembly. As you are no doubt aware by now, the continuous and almost serial underfunding by the federal government of its key law enforcement and security agencies is what compelled the governor, in order to fulfill his campaign promise, to design a collective, sustainable, accountable response to the very serious problem of security. The Trust Fund is a key implementation part of Lagos State's strategic policy on crime and safety and provides a clearly identifiable institutional framework for engaging with the public and for raising and distribution of

security assets acquired through this engagement.

We are now in the sixth year of operation and within this period our combined efforts have had a profound impact on the resource base of the various security agencies and their ability to adapt to the ever-changing dynamics of crime, and the critical role of the Fund has expressed itself in its ability to respond to requested and justified security needs as and when they arise, such as responding to the recent rise in threat levels due to national and local situations that are outside the immediate control of Lagos State. Indeed we are now the first port of call when the security agencies need urgent logistic support, a quick reacting warehouse of support. As an example of such support, in the period since inception, the Fund has been able to transfer over 600 fully kitted vehicles to the various security agencies on your behalf.

We must acknowledge that we are not the final answer to the problems of federal under-resourcing and 600 vehicles is still not sufficient to provide security response to all the growing towns and communities of Lagos State – Lagos Island, Mushin, Lekki, Ajah, Ikorodu, Okokomaiko, Victoria Island, Ajegunle, Bariga, Oworonsoki, Yaba, Akoka, Apapa, Ajangbadi, Epe, Pedro, Palm Grove, Makoko, Maryland, Ikeja, Opebi, Ogba, Alausa, Badagry, Ojo, Alaba, Ishashi, Okota, Idi-Oro, Akowonjo, Shasha, Osodi, Obanikoro, Oke-Odo, Agege, Ikoyi, Falomo, Ipaja, Okota, Ijegan, Obalende, Gbagada, Anthony, Boundary, Ojodu, Omole, Amukoko, Amuwo-Odofin, Ilupaju, Ketu, Alapere, Festac, Idimu, Egbeda, Ijainikin, Suru-Lere, Jibowu, Onike and so on and so on.

That is not our role, and two decades worth of capacity deficit requires a mighty effort on the part of those constitutionally charged with

EXECUTIVE SECRETARY'S INTRODUCTION

the security funding mandate to redress. Beyond logistics are internal issues of welfare, administration, discipline, recruitment, training, deployment, working conditions and the like and these are outside the remit of the Lagos State Government and the Security Trust Fund. But there is no doubt that without the commitment of His Excellency the Governor as indicated by the continuous and decisive intervention of the LASG, and the support of your good selves through the Fund, we would be literally under relentless and unrelenting siege with almost zero capacity to react.

### OPERATIONS OF THE FUND

The Fund, operating through its Board of Trustees under the very capable and committed leadership of Mr. Remi Makanjuola and with minimal administrative cost, has worked diligently to fulfill its statutory mandate of fund raising and support for safety and security in Lagos State. The Fund, being essentially autonomous, though acting in tandem with government's strategic goals, receives no cash subvention from government, and ALL its cash assets comprise donations from corporations, foundations, associations, churches, mosques and

private individuals including school children, some of whom have been year-on-year donors since inception. I want to thank all the donors for their support for, without you we would not be able to function and the situation would be dire indeed.

Significant also is the fact that the Fund has gradually taken on the role of dedicated security asset manager and maintainer, something that was almost completely absent before the establishment of the Fund. So in effect, the Security Trust Fund represents your collective ownership of all the assets donated, distributed and deployed, and therefore places pressure on the recipients in terms of accountability, and ensuring that the assets are duly serviced, maintained, repaired and replaced according to operational need and resources available. For instance, the APC that was severely damaged by over sixty direct hits from AK 47s while responding to a distress call in the Lekki/Ajah area about a month ago was immediately approved for repairs by the Board. Let me underline the fact that without the Trust Fund it would have been parked and forgotten like the over 280 APCs that have been abandoned across the country over the years and we would have been the worst for it.

### THE ROLE OF THE POLICE

We often disparage the police but I can assure you that they are very brave men and women. We are at the moment repairing the Oke-Odo Division patrol vehicle, a donation from the Fund, which was riddled by bullets as they responded to a distress call from Unity Estate, Idimu. They dislodged the robbers and happily, no policeman or victim was killed. We have had many such incidents where in the course of fulfilling our maintenance and repair role, we have heard stories of great bravery and courage. Indeed you will hear from his Excellency another tale of bravery and tragedy beyond the call of



duty later on, and from the CPs report you will hear of the sterling and proactive work they have done in prevention. We must support these men for they literally put their lives on the line for us. We must get to know our DPOs and their challenges and involve them and their men in our social lives especially during holidays and festivals, not getting to know them only after an incident.

**EXPANSION OF THE DONOR BASE**

The Fund is proud of the fact that our partnership with the private sector is growing continuously, and since the last town hall meeting we have had many more corporate organizations and individuals join the role of honour as donors, or should I say 'investors'. The list of all the donors is contained in the brochure but I must mention for the record the addition of the UAC Group, CocaCola Plc., Airtel, Folawiyo Petroleum, Zinox and the Abodurin Foundation to our list in 2012. Also I am happy to announce the personal commitment of support to the Fund made by the Nigerian Breweries through its managing director to the Governor at a recent meeting. And I acknowledge the private citizen donors, some of whom walk off the street into a bank and donate. This is clear evidence of acknowledgement that our model is a trusted and viable one, and that while the federal government continues to scratch its head while it struggles with its decade long consideration (not implementation) of the various reports of presidential committees on police reform, there is really no alternative to the partnership at the present time.

It is important that I underline one very relevant fact on the issue of security, which we often overlook –security and law enforcement is, apart from health care, the only truly 24/7 operational structure in the public service space. This means that there is great stress on both men and equipment and because of the nature

of violent crime the rate of attrition is high. And the criminals never relent because crime is a business, and though we like to say that 'crime does not pay', for many professional criminals crime is all they know. And because of the current security, economic and environmental situation in Nigeria, the stress is increasing. And as the stress increases so does the cost both in men and materiel.

In partly responding to this situation have established a sinking Fund of over 25 million naira to cover the insurance (repair and replacement) of our assets –APCs, patrol vehicles and motor cycles, but your support still lies at the heart of our functions.

**2012 EXPENDITURE**

This has been a very busy year for the security agencies and thus a busy year for the Fund. If you compare our expenditure for 2011 with expenditure for 2012 you will notice a marked upswing indicating the increased stress I referred to. In 2011 we spent N249,302,000 as against an expenditure of N467,953,000 in 2012, helped in large part because there was a marked increase in donations –N476,000,000 since the last town hall meeting as against N173,695,150.00 in 2010 and N186,360,000.00 in 2011. In 2011 we ended the year with a balance of N52,027,967.00 while

for 2012 we have a balance of N60,455,000.00. We will certainly need, in line with the theme of today's meeting and the pressing reality of the times, to urgently re-inflate this balance to enable us to continue carrying out our very important functions.

In addition to the above we received donations from private companies and foundations of equipment valued at over N90,000,000.00.

A look at our expenditure list for 2012 shows that most of it went on keeping the heart of the security infrastructure beating and also pumping fresh blood where there were leaks –so we kept up the maintenance of existing assets (and boarded those that were beyond economic repair to deserving officers), infused new vehicles into the fleets of our usual clients, bought uniforms, ballistic gear, rain gear and sundry personal kit items along with searchlights and radios for the police, assisted the prisons with bomb detection equipment (because they are holding Boko Haram suspects), repair of vehicles and supply of drugs, upgraded the State Security Service's repeater station and mast, fuelled the marine police and the navy, and generally intervened where assistance was needed. For instance, it was the quick response of the Fund that enabled the deployment of a second Quick Reaction Group (QRG), comprising special units of the army to support the police in securing the VI/Lekki/Epe corridor. The first QRG is deployed from Ojodu-Berger to Ogere along the Lagos-Ibadan expressway.

The Trust Fund, appreciating the need to support security at the community level has also been involved in support for the Neighbourhood Watch, a vital yet sometimes overlooked component of the security infrastructure. This is a body of local citizens established by law, made up of mainly volunteers who are members of their communities and who assist in intelli-

gence gathering, street patrols, venue protection and arrest of suspected criminals, and they have played a very useful though largely unacknowledged role in community safety. In the face of current challenges, the Fund has deemed it fit to support them by the provision of radios, electric batons, military issue disposal handcuffs and training to improve their communications skills and defensive and offensive capacity.

### ROLE OF THE STATE AND LGAS IN SECURITY SUPPORT

Critically the Lagos State Government and the 57 LGCs and LCDAs have kept up their support for the security agencies in line with their philosophy of leading by example. In this wise the LASG donated two 900hp armored patrol boats with thermal imaging and night vision capability to the navy along with their usual fuelling support of over N500 million (up from last year due to partial subsidy removal) and continued payment of allowances and ration cash allowances to all operatives involved in security patrols and distress response. The LGAs on their part donated 114 vehicles (their second of such donations), distributed amongst the police divisions across the state. The state government is expending huge sums in building or rebuilding critical police infrastructure, such as the Area C building in Surulere which is about completed, and commencing the building of the five new Area Commands approved by police HQ. Taken together this amounts to about N2.5billion without taking account of other contingencies to do with accident and emergency management and special operations including joint raids.

### THE BOARD OF TRUSTEES

At this stage, let me use this opportunity to introduce to this citizen-gathering the gentlemen who have been at the forefront of the Trust Fund's activities, the gentlemen who have over the past year have sacrificed their time to ensure that the Fund is run efficiently and have infused

crucial that you continue to support the efforts of the Fund as we confront the reality of an increasingly dangerous world where events in Libya, Somalia and Mali have led to a troubling proliferation of small arms. I am sure most of us heard of the Kenya incident where 42 policemen were slaughtered in one single operation against cattle rustlers who were armed with AK 47s and RPGs. The city of Sao Paulo in Brazil with a population similar to our own experienced 984 murders in the

first ten months of this year, with October alone recording 144 murders, as compared to 15 in Lagos in the same month. That is the reality of today; RPGs are increasingly being discovered in the arsenals of local criminals as the Commissioner of Police's report will indicate, and we must therefore make every effort to ensure that our men and women are well prepared to face this current reality.

Let me echo the Chairman of the Board by thanking all those who have continued to support this collective endeavour and fervently appealing to those yet to do so to throw their hats in the ring in support of building a viable and sustainable security and safety structure in Lagos State, to enable the maintenance of improved quality of life and a healthy investment climate. In an imperfect society such as ours, some of us, especially those of us who understand the true meaning of civic duty, have to take responsibility for putting things right.

### CHALLENGES AHEAD

As we review our activities over the past year and look to the future it is clear that we face serious challenges. Forced dislocations all over the country have led to a tide of migrations, and Lagos being the mother city is always a preferred destination. The problem is that not all these migrants are good citizens. In addition, and I have made this point in the past, the continuing intensive military operations in some parts of the North has meant that while the ideologues remain to fight, the career criminals move out looking for 'softer' targets. There are also incursions from neighbouring states and the South-East and South-South. This means that we must continue to nurture and grow our 'iron dome' protection system so that we do not become victims of other peoples' problems. It is therefore

## STATEMENT OF TRUSTEES' RESPONSIBILITIES



The Trustees accept responsibility for the annual financial statements, which have been prepared using appropriate accounting policies supported by reasonable and prudent judgements and estimates, in conformity with Nigerian Accounting Standards and the requirements of the Lagos State Security Trust Fund Law.

The Trustees are of the opinion that the financial statements give a true and fair view of the state of the financial affairs of the Fund and of its surplus or deficit. The Trustees further accept responsibility for the maintenance of accounting records that may be relied upon in the preparation of financial statements, as well as adequate systems of internal financial control.

Nothing has come to the attention of the Trustees to indicate that the Fund will not remain a going concern for at least twelve months from the date of this statement.

## REPORT OF THE INDEPENDENT AUDITOR TO THE TRUSTEES OF THE LAGOS STATE SECURITY TRUST FUND

### Report on the financial statements

We have audited the accompanying financial statements of Lagos State Security Trust Fund which comprise the balance sheet as of 31 December 2011 and the income and expenditure account, and statement of cash flows for the year then ended and a summary of significant accounting policies and other explanatory notes.

#### *Trustees' responsibility for the financial statements*

The trustees are responsible for the preparation and fair presentation of these financial statements in accordance with Nigerian Statements of Accounting Standards and with the requirements of the Lagos State Security Trust Fund Law and for such internal control, as the trustees determine necessary to enable the preparation of financial statements that are free from material misstatements, whether due to fraud or error.

#### *Auditor's responsibility*

Our responsibility is to express an independent opinion on the financial statements based on our audit. We conducted our audit in accordance with International Standards on Auditing. Those standards require that we comply with ethical requirements and plan and perform our audit to obtain reasonable assurance that the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgement, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Fund's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by the trustees, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

#### *Opinion*

In our opinion the accompanying financial statements give a true and fair view of the state of the Fund's financial affairs at 31 December 2011 and of its surplus and cash flows for the year then ended in accordance with Nigerian Statements of Accounting Standards and requirements of the Lagos State Security Trust Fund Law.



## STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

The principal accounting policies adopted in the preparation of these financial statements are set out below. These policies have been consistently applied to all years presented, unless otherwise stated.

### (a) Basis of preparation

The financial statements are prepared in compliance with Nigerian Statements of Accounting Standards (SAS). The financial statements are presented in the functional currency, Nigeria Naira (N), and prepared on a modified cash basis under the historical cost convention.

### (b) Revenue recognition

Donations are recognised when pledges are made. Revenue represents fair value of cash or in-kind donations. Value added tax is not charged on revenue.

Interest income is recognised on a time proportion basis using the effective interest method.

### (c) Property, plant and equipment

Property, plant and equipment are shown at acquisition cost less accumulated depreciation. Acquisition cost represents purchase price plus freight, insurance and handling charges. For assets donated to the Fund, acquisition cost represents fair value of donated assets.

Repairs and maintenance are charged to the Income and expenditure account during the financial period in which they are incurred.

Depreciation is calculated using the straight line method to write down the cost of assets to their residual values over their estimated useful lives, at the following annual rates:

### (d) Expenses and support to security agencies

Expenses are recognised when incurred. Support to security agencies are in kind donations and they are recognised as expenses when the receiving agency acknowledge receipt of delivery.

### (e) Inventories

Inventories are stated at the lower of cost and net realisable value through the first-in, first-out (FIFO) basis. Cost represents purchase price and other ancillary costs directly associated with the purchase. Net realisable value is the market value less cost to sell.

### (f) Accounts receivable

Receivables are recognised initially at fair value. Subsequently, they are stated after deduction of specific provision for any pledge considered to be doubtful of recovery. A provision for impairment of receivables is established when a pledge made in a particular year is outstanding up till the time the annual financial statements of that year is about to be signed off and circulated. The amount of the provision is recognised in the Income and expenditure account.

## NOTES TO THE FINANCIAL STATEMENTS

### 1 The Fund

The Lagos State Security Trust Fund was established in 2007 by a law of the Lagos State House of Assembly to raise and coordinate the application of donations in cash and equipment which are required to enhance the operational capacity of security agencies operating in the state. The money thus raised is to be used for the acquisition and deployment of security equipment and such human, material and financial resources as shall be found necessary for the effective functioning of all Federal, State and Local Government and other security agencies operating in the State. In addition, part of the fund shall be reserved for the training and retraining of security personnel.

#### INTRODUCTION

It is with a great sense of honour and responsibility that I stand before you all today to present a report on the activities of the Lagos State Police Command under my stewardship covering from November, 2011 to October, 2012. I am most humbled and privileged to work as a Commissioner of Police under His Excellency, the amiable, intelligent and indefatigable Governor of Lagos State, Babatunde Raji Fashola (SAN), who since the inception of the LSSTF in 2007, have continued to provide the enabling environment and requisite tools to fight crime and criminality in Lagos State; a gesture that has made Lagos State Police Command unique and a model for other State Commands in the country to emulate.

2. On my assumption of office on the 12th of March, 2012, I leveraged on the robust goodwill existing between the police and the state government on one hand and members of the public on the other, to record the modest achievement, that has not only consolidated that of my predecessors, but has ensured that the flag of keeping Lagos and Lagosians safe is kept flying.

3. The special position of Lagos in the socio-economic and political landscape of Nigeria has placed mammoth task and security challenges at the doorsteps of the command. But the innovative approach of the Lagos State Government to set up a Security Trust Fund as a means of bolstering security in the state through capacity building has immensely impacted positively on security of lives and property in the state. Only recently, on September 10, 2012 to be precise, the Command once again received the following list of items from the State Government:-

- i. **One hundred and fourteen patrol vehicles;**
- ii. **Four lorries (troop carriers);**
- iii. **Forty motorcycles;**
- iv. **One mobile ambulance;**
- v. **One hundred units of riders' kits;**
- vi. **One hundred and fifty bullet proof vests;**
- vii. **One hundred and fifty walkie talkies and**
- viii. **One hundred ballistic helmets.**

4. Without doubt, the Police Command cannot function without the collaboration of the host state government, Lagos State and her donor agencies. Indeed, members of the public have continued to offer useful information to the police that has aided the foiling of many criminal acts. I want to use this medium to urge members of the public not to relent in giving the Police useful information, including advice and criticism that will lead to the enhancement of security in the state.

5. It is regrettable that on the 9th of September, 2012 a day before the launch of the above items, hoodlums held the state by the jugular, during which a bureau de-change was robbed, three policemen and a civilian were killed and several

others injured. But I have to state that within the last few days, crime have not only been prevented, but have been cracked or nipped in the bud when committed. This is due to the addition of the above equipment to the fleet of the command and the quick response to distress calls and the scrupulous and diligent use of information volunteered by members of the public and tools at the disposal of the police to do the job. To highlight a few:

### **i. ARREST OF KIDNAPPER**

On 22/04/2012 at 1200 hours, DPO Ikoyi, SP Aisha Haruna assisted by operatives from Special Anti-robbery squad Ikeja arrested one Emmanuel Emeka Nwangwu 'm', a wanted notorious kidnapper and his wife Patricia Abena 'f', a Ghanaian, both of no fixed address, at Garki area, Abuja. The arrested kidnapper was responsible for the kidnap of numerous persons for ransom, among whom are the son of Mr Folarin F. Coker, Ex-Deputy Chief of Staff Lagos; the daughter of Afam Edozie, one of the Directors of MTN in 2009, where a ransom of \$100,000 us dollars was paid and the son of Mrs Folusho Odegbaide of Magodo Estate, Isheri where N2.5 Million was paid. The suspect collected the ransom through ECOBANK Ghana at different times.

### **ii. ARREST OF ARMED ROBBERS/ RECOVERY OF STOLEN VEHICLES**

On 03/05/2012 about 0330hrs, Policemen attached to Special Anti-Robbery Squad Ikeja that acted on a tip-off arrested three members of a notorious car snatching syndicate, John Sunny Eruteye 'm', Joseph Dimpka 'm' and Taiye Isiaka 'm' at Ijanikin area with four stolen vehicles:

- A Honda CRV Jeep Reg. No. ES-101-FST;
- Honda Accord Saloon Car Reg. No. CF-97-KSF;
- Toyota Sienna Space Wagon Reg No. FKJ-680-AA and
- An unregistered Toyota Sienna Space Wagon.

### **iii. ARREST OF BANK ROBBERS/RECOVERY OF ARMS/ AMMUNITION**

On 10/05/2012 about 1700 hours, one Sodiq Yinusa 'm' was arrested at the vicinity of Guaranty Trust Bank(GTB) Plc, Ifako/Gbagada branch while waiting for other members of his gang to attack the bank by Special Anti-Robbery Squad and PMF personnel. Based on his confessional statement, other gang members: Arnold Dokpesi 'm', Sunday Orukpe 'm', Timi Bozimo 'm', Matanmi Oladipupo 'm' and Adesida Kehinde 'm' were arrested in their respective hideouts at Alakuko, Alagbado and Ikeja Military Cantonment. Two locally made revolver pistols and eleven .99mm caliber live ammunition were recovered from Arnold Dokpesi 'm' and Sunday Orukpe 'm'.

### **iv. ARREST OF ARMED ROBBERS/KIDNAPPERS**

On 12/05/2012 about 1700 hours, a team of policemen attached to Special Anti-Robbery Squad, arrested seven armed robbers/kidnappers; Esther Philip 'f', Patricia Inna 'f', Kingsley Okonwa 'm' Aka Dragon, Osita Adigbe 'M' Aka Ossy, Uzochukwu Ezioha 'M' Aka Black, Jude Sunday 'M' Aka Bulldozer, Olarewaju Michael 'M' Aka Mike in their hideouts. The suspects kidnapped one Ayodele Olaye 'm' at Iyana School Bus Stop, along Iba-Igando Road on 22/04/2012 and took a ransom of five million (N5, 000,000:00K) from his father before releasing him on 25/04/2012. Meanwhile, a sum of one million, six hundred thousand naira(N1, 600,000:00K) out of the ransom collected has been recovered.

### **v. FOILED ATTACK ON ATM/ATTEMPTED MURDER OF POLICEMAN/RECOVERY OF MONEY**

On 02/06/2012 about 0300 hours, Police patrol team attached to Area 'E' Command Festac that responded to distress call, exchanged gunfire with armed robbers that attempted to rob ATM

at Skye Bank Plc, Festac Branch. The robbers tied the hands and legs of the two security guards, damaged the ATM and shot F/No. 194136 Sgt. Femi Ikupoluyi in the left leg. Two gas cylinders, two big chisels; three ATM money cassettes containing the sum of Three Million Four Hundred and Eighty Thousand Naira were recovered from them. The injured NCO is admitted at AMC Hospital, Festac

**vi. ARREST OF ARMED ROBBERS/RECOVERY OF STOLEN VEHICLES**

Policemen attached to Special Anti-Robbery Squad Ikeja arrested nine armed robbers Augustine Amgbeye 'm', Saviour Amgbeye 'm', Chima 'm' other name unknown, Sunday Odeh 'm', Ikechukwu Maduka 'm', Lawrence Ebibitdo 'm', Chuks Osuegwu 'm', Patrick Akpan 'm' and Jeremiah Amgbeye 'm' at various hideouts. The robbers conspired with Ugo Austin 'm', a staff of Kunnech Group of Companies Nigeria limited at No.14, Ajeniran Road along Epe expressway to rob the company

on 20/05/2012 of five brand new vehicles - two unregistered Toyota Fortuner Jeeps, two unregistered Toyota Camry S/Cars and one unregistered Toyota Corolla S/Car. The robbed vehicles have been recovered from the suspects.

**vii. ARREST OF ARMED ROBBERS/RECOV-**

**ERY OF ARMS AND AMMUNITION/VEHICLE**

On 18/07/2012 about 0200 hours, Policemen attached to Special Anti-Robbery Squad Ikeja that acted on a tip-off laid ambush and arrested three members of a notorious armed robbers, Adewale Adeniyi 'm', Oluwaseyi Showemimi 'm' and Ladun Agemo 'm' that had been terrorizing Lagos State based in Ado-Odo, Ogun State while on their way to strike in Lagos. The following items were recovered from the gang:-

- Four AK-47 rifles Nos. 1973, 615772, AD-356082, 54069
- One AK-47 riffle with defaced number,
- Twenty nine magazines,
- Eight hundred and seventy rounds of 7.62mm calibre live ammunition and
- A Madza 626 saloon car with Reg. No. APP-395-QA

**viii. CONSPIRACY AND MURDER**

On 22/07/12 about 1400 hours, one Cynthia Asokogu Udoka 'f' 25 years old was strangled to death at Cosilla Hotel, Amuwo-Odofin, Festac Town by one Okwumo Echezona Nwabufu 'm', 33 years old and Ezike Ilechukwu Olisaeloka 'm' 23 years old. The suspects were arrested on 07/08/12 at their respective hideouts. One International

Passport, Driver's Licence, a pair of shoes, hand-bag, artificial sex toy vibrator, a jewelry pack containing three(3) wristwatches, four rings, three(3) pairs of earrings, one(1) pendant, one(1) necklace, one (1) hand chain and a single earring all the deceased property were recovered from the suspects. The suspects and two Pharmacists have been charged to court and case adjourned to 3rd October, 2012. However, further investigation led to the arrest of two suspects- Nonso Ejike 'm', aged 21yrs and Gideon Okechukwu 'm', aged 35 years in Port Harcourt and the Blackberry phone of the deceased at the time of death was recovered from them.

### ix. ARREST OF ARMED ROBBERS

On 26/08/2012, one Onyeka Eboma a dismissed Policeman and the kingpin of a notorious armed gang earlier arrested and charged to Chief Magistrate Court 2, Ikeja on 28/7/2011 with his gang members for conspiracy, armed robbery of Bank PHB, Akowonjo and murder of one Ogundipe Sunday, a security man attached to the bank. Subsequently the notorious armed robber was granted bail in December, 2011 despite the Directorate of Public Prosecutions(DPP), Legal Advice with reference No. LJP/RT.2011/128/44 dated October, 2011 indicting the suspect and three others for conspiracy, armed robbery and murder. The suspect on his unjustifiable release returned to his armed robbery business and carried out series of attacks on Banks' Automated Teller Machines(ATMs) in the State. As a result, F/No. 258359 Cpl. Babatunde Sadiku attached to PMF 20 on guard duty at Access Bank, Ijeshatedo was shot dead on 3/6/2012 during one of their operation and his rifle carted away. As a result of incessant attacks on banks' ATMs, the Command launched a massive manhunt against the suspect and his gang by SARS team and eventually he was re-arrested.

### x. ARREST OF KIDNAPPERS/RESCUE OF VICTIM/ RECOVERY OF VEHICLE

On 03/09/2012 about 2350 hours, policemen attached to Special Anti Robbery Squad(SARS) arrested one Kelechukwu Onyema 'm', 27 years old; Pius Uba Livinus 'm', 25 years old and Ayebe Segun 'm' 32 years old at Ajao Estate. The suspects had on 2/9/12 kidnapped one Yahaya Aminu, a staff of Dangote Group, Head Office, Falomo, Ikoyi at Guarantee Trust Bank(GTB), Awolowo Road, Ikoyi. The victim was rescued alive while two locally made pistols with sixteen cartridges and one Kia Cerato S/Car, Reg. No. DN-735-APP belonging to the victim were recovered from the kidnappers. It is noteworthy to state that on 17/2/2012 about 2230hrs at Oniru Estate, Lagos the same Pius Uba Livinus with others at large were responsible for the kidnapping of Mr. Debasis Mitraroy 'm' of Dangote Group of Company. The suspect was eventually charged to Magistrate Court 17, PWD, Ikeja presided over by Magstrate A. O. Akinde for conspiracy and kidnapping via Charge No. MIK/R/42/2012 on 5/4/2012 but was strangely released in May, 2012 by the Court from where he immediately went back to his kidnapping business.

### xi. ARREST OF KIDNAPPERS/RECOVERY OF ARMS/ RESCUE OF VICTIM

The victim was rescued.

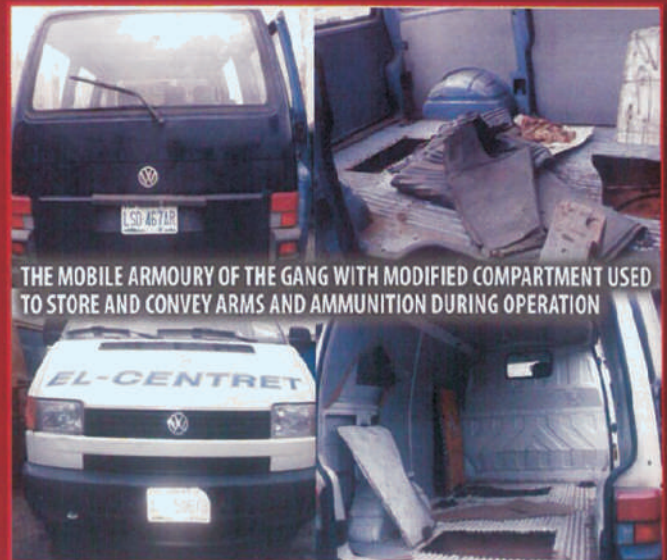

- Nine AK-47 rifles;

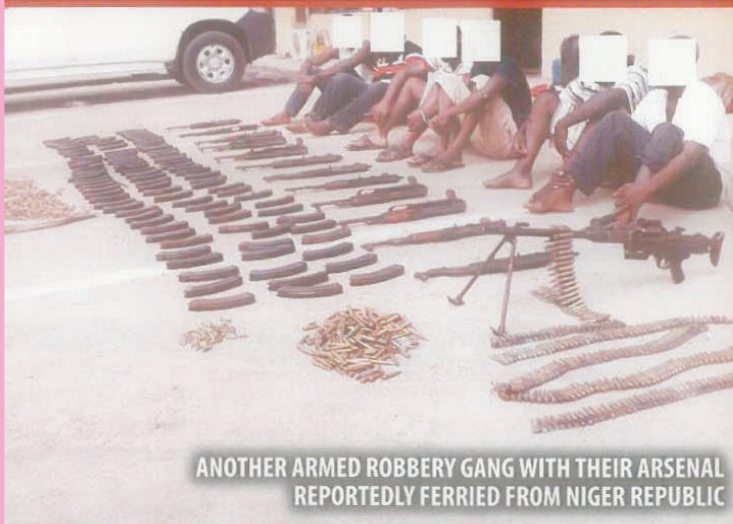

It has to be noted that Victor Sunday and Eno Victor were earlier charged to court in 2011 for another case of kidnapping by Force CID Lagos and returned to their stock in trade immediately they were released.

These are just a few in a string of breakthroughs the command has recorded against hoodlums who now find the state unviable for their nefarious activities.

orts.

It must also, be emphasized that equipment do not have eyes, nor do they have ears. Therefore, they must be operated by officers and men with the right vision and passion and who would put such equipment into effective use in order to realize the intended objectives. In this wise, the command will require additional manpower preferably rank and files and accommodation.

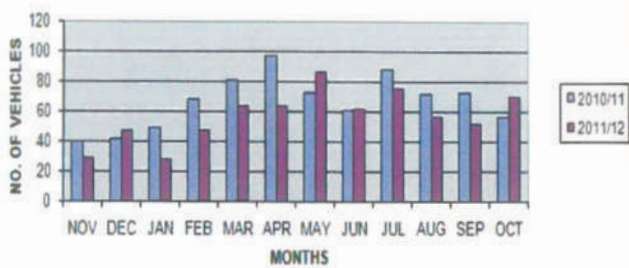

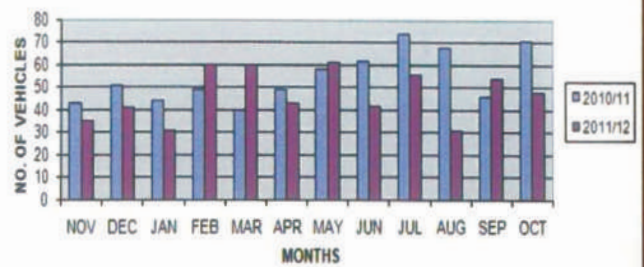

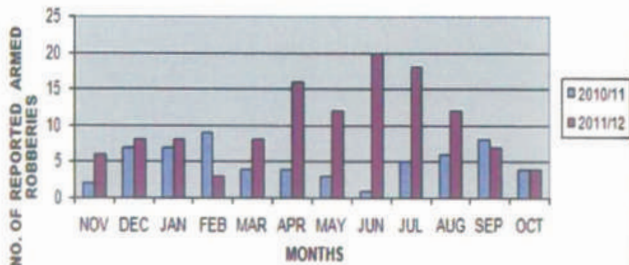
**CHART SHOWING NO. OF VEHICLES SNATCHED BETWEEN NOV 2010 AND OCT 2012**



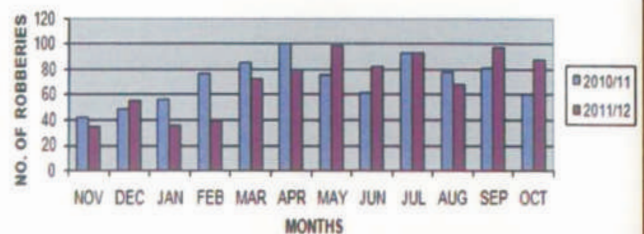
**CHART SHOWING NO. OF VEHICLES REMOVED FROM PARK BETWEEN NOV 2012 AND OCT 2012**



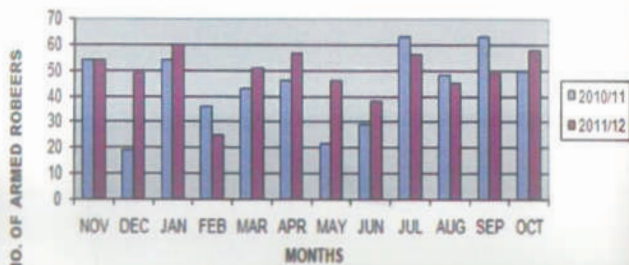
**CHART SHOWING NO. OF REPORTED ARMED ROBBERY INCIDENTS BETWEEN NOV 2010 AND OCT 2012**



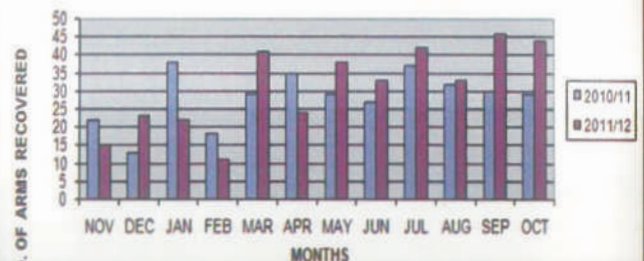

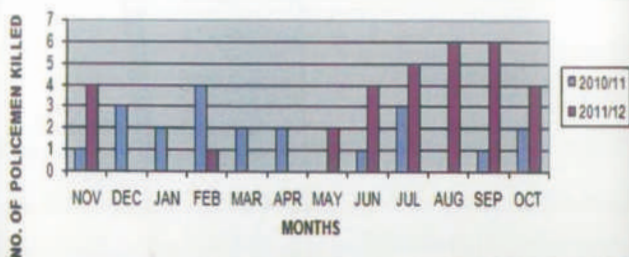
**CHART SHOWING NO. OF ARMED ROBBERS ARRESTED BETWEEN NOV 2010 AND OCT 2012**



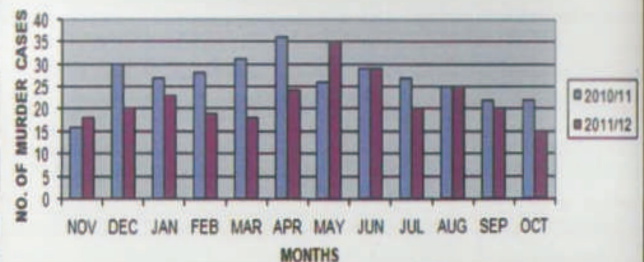
**CHART SHOWING NO. OF ARMS RECOVERED BETWEEN NOV 2010 AND OCT 2012**

## SECURITY AND SAFETY TIPS

**Below are some vital security tips compiled by the Lagos State Police Command and the State Security Service (SSS) under the instrumentality of the Lagos State Security Council for the benefit of the general public.**

### HOME/RESIDENTIAL SECURITY

- All doors and gates should have quality locks. It is essential to check all doors in your home at bedtime and while leaving the house;
- Do not hide your keys outside the home;
- Keep all doors locked even when at home with members of your family;
- Have window locks;
- Ensure your external power sources are properly installed and locked with keys;
- Do not block bedroom windows with permanent grilles as the windows may be used as emergency exits, equally review fire safety exit if you have window bars and grilles;
- If you have burglar or intrusion alarms installed, check and switch them on at all times;
- Ensure you have fire extinguishers in your home, especially the kitchen and show the entire household how to use them;
- Always make sure you have flash lights (torch light etc) at points that can be reached easily;
- Keeping of pets like dogs can be a deterrent to criminals but never install separate doggy doors or entrances as they also can admit small intruders;
- Know your neighbours, develop rapport with them and offer to keep an eye on each other's home, especially when you are on a trip or out of town;
- If you observe any unusual activity or movement around, report to the nearest security post (Police);
- Ensure that your family understands and appreciates your security patterns and let them know that the measures emplaced are for their safety;
- Rehearse safety drills with your family and let

them be aware of procedures to escape danger and get help where necessary;

- Know where all family members are at all times; Vary your daily routines and avoid predictable patterns;
- Educate family members on the proper way to answer the telephone at home, let them know what to do when you are not at home and how to receive visitors while keeping eyes on them;
- Ensure adequate physical security, good fencing, good illumination, mounting centric wire;
- Identify visitors properly before opening the gate or door;
- Look behind you when driving home;
- Look around your environment as you approach your home;
- Install CCTV camera's if you can afford the cost for surveillance;
- Be careful when a neighbour knocks on your door at odd hours as criminals can use them to gain access to your home;
- Join the residents' association;
- If it is possible employ a guard to mount your gate;
- Do not encourage members of your household to keep late nights.

### HOME SECURITY WHILE YOU ARE AWAY

- Secure your home before leaving, close and lock all windows and doors, garages and gates;
- Switch on outside lights and replace burnt-out light bulbs;
- Ask a friend, colleague or neighbour to help check your home periodically while you are away;
- Unplug all appliances, TV, Radio etc.;
- Lock all jewellery, important documents, currency and other valuables in a safe place.

### PERSONAL SECURITY TIPS

- Gain adequate security consciousness or education as well as habitual practice of tips learnt;
- Always observe security drills and procedures;
- Avoid membership of secret cults and criminal syndicates;
- Avoid ostentatious lifestyle and rigid routines that you could easily get identified with, like going

to particular places at given times and days or following the same route every time;

- Be conscious and wary of such human weaknesses as drunkenness, flippancy, sexual promiscuity, drug addiction and gambling, among others;
- Avoid lonely routes and do not disclose schedules to strangers and others you may have any reason to doubt;
- When confronted with a weapon remain calm, and if taken hostage cooperate with your captors but try to cautiously appraise the place(s) of your captivity;
- Always lock all your car doors during any journey, no matter how short;
- Always watch out for and monitor strange faces in your neighbourhood;
- If you are driving be observant and conscious of being followed. A warning signal is when the same car is noticeable behind you through various traffic routes;
- Do not wear provocative dresses in religiously conservative areas;
- When in a chartered taxi, always sit at the back, lock up the doors and never allow the driver to make any stops for any person; and
- Be civil with members of the public.

### FAMILY SECURITY TIPS

- Always sensitize members of your family on security tips gained through security awareness;
- Further sensitize family members on emerging threats against human health as well as new crime trends;
- Keep dangerous objects away from children; and
- Endeavour to Vet and re-vet domestic staff through the service of the SSS.

### SECURITY TIPS FOR CHILDREN

- Teach children never to admit strangers into the home;
- Teach children local emergency phone numbers (Lagos - 112 and 767). Make sure younger children know their name, address, and phone number;

## SECURITY AND SAFETY TIPS cont'd.

- Get to know all your teenagers friends;
- Caution teenagers about "blind dates" or meeting anyone they do not know;
- Teach younger members of your family not to open mails or packages;
- Teach young children how to answer the telephone so that they do not give out personal information, such as home address, absence of adults, etc. ;
- Teach children how to say "NO" to strangers;
- Teach children how to exit the house in case of emergency.

### OFFICE SECURITY TIPS

- Be respectful of colleagues and other associates;
- Do not divulge office information to staff and non – staff without authorization;
- Learn and adhere to the rules and regulations governing your employment;
- Avoid amorous affairs in your office environment;
- Be cautious of friends who always wish to discuss official matters when they visit you or take you out on social outings.
- Avoid discussing official or personal/financial information on the phone;
- Be cautious of colleagues who may exploit your relationship to gain unauthorized access to information within your domain; and
- Always ensure sensitive office equipment and documents under your charge are properly secured at all times.

### TRAVELLING SECURITY TIPS

- Avoid night travels and always keep enough money for emergency situations like boarding of fresh conveyance;
- Do not wear excess jewellery and always dress casually;
- Be wary of discussing your travelling/business plans;
- If on a flight adhere to all security instructions, and while on road transport, be cautious in sharing food with strangers;
- Keep away from any luggage not attended to in the hotels, airports or other public places.

### KIDNAPPING SECURITY TIPS

- Install CCTV cameras at home to monitor movements of people outside your home;
- Keep emergency numbers with you at all times.
  - You can create speed dial numbers in your mobile phone just in case you find yourself in a very compromising situation;
  - Do not give away any personal information such as your phone numbers and home address, especially on social networking websites or to persons unknown to you;
  - Create a peephole in your door, where you can check out the person at your door before letting him or her in;
  - Opt for clear glass windows to observe a person from a distance;
  - If you do not have a gate or fence, lock all the doors at all times;
  - Watch what and where you speak, especially on the phone. A lot of people have no sense of security while speaking, and could end up bragging yourself into being kidnapped and asked to pay a ransom;
  - Be alert to suspicious and unusual behaviour happenings around you;
  - Do not leave bags or money lying around in your car, home or office;
  - Do not discuss financial matters in open places and not even in the car or within the hearing of your domestic staff;
  - Avoid huge cash transactions; use ATM or online transfer where necessary;
  - Do not leave your children in a car unattended, particularly while shopping, refuelling or on social outings;
  - Do not carry black nylon bags or big brown envelopes; it may attract criminals;
  - Be discrete in your philanthropic gestures as this could make you a target; and
  - Schools should install CCTV in the school surroundings to monitor activities in and around the premises especially at opening and closing times.

### ROAD SAFETY (ROAD TRAFFIC LAW)

- Do not use your phone or send text messages while driving. Use of phones while driving increases the chances of accidents by 300% and is against the Law;
- Even when using phone with hands free application as approved by the Traffic Law, do not engage

- in long conversations as this absorbs all your attention increasing the chance of accident/ robbery;
- Ensure that all your vehicle lights (head lamps, rear lights, brake lights, and indicators) are functioning. Car owners, office fleets, delivery trucks/vans, tankers (NUPENG), Buses (Staff, NURTW, BRT/LAGBUS) should note for compliance. Non working lights are dangerous especially at night. This is a safety issue;
  - Do not drive against traffic;
  - Be considerate of and courteous to other road users.

### SECURITY TIPS IN HOTELS

- Do not discuss your business or travel plans in public areas where you may be overheard. Discuss your travel plans and movements during your stay with as few people as possible;
- Do not entertain strangers in your hotel room;
- Be alert to overly friendly locals who may have criminal intentions. They may offer to take you to a "special" restaurant. Their ruse may be to offer drugged refreshments;
- Never leave valuables in your hotel room exposed or unattended to, even in a locked suitcase;
- Place valuables, money, jewelry, airplane tickets, credit cards, passport, in a hotel safe deposit box or room safe;
- Familiarize yourself with escape routes in case of fire or other catastrophe;
- Use the door chain or bolt lock whenever you are in your room;
- Use the door viewer (peephole) before opening the door to visitors.
- Do not discuss your room number, while standing in the lobby or leave your room key on restaurant or bar tables;
- Keep your room neat so you will notice disturbed or missing items quickly.

## REPORT OF THE ACTIVITIES OF OP MESA, ARMED FORCES' (ARMY, NAVY AND AIR FORCE) SPECIAL SECURITY OUTFIT

### INTRODUCTION

OP MESA is a military security outfit which provides support for civil security agencies, especially the police, in the discharge of their statutory responsibilities. OP MESA comprises officers and men of the Army, the Navy and the Air Force under the command of Brig. Gen. Pat Akem, Commander 9 Brigade, Navy Commodore MJO Njoku, Commander, NNS Beecroft and Air Commodore Toyi Omenyi, Commander Air Force 435 Base. The military are currently involved in internal security operations aimed at maintaining law and order in 27 States of the federation in line with the provisions of Section 217 of the Constitution of the Federal Republic of Nigeria 1999. OP MESA's primary responsibility is anticrime patrols although they participate in joint raids of identified Black Spots with other agencies such as the police and SSS and in responding to distress calls.

### Mode of Operations

OP MESA operates a 24 hour daily mobile and static patrols in their predetermined areas of operation which also include public infrastructure.

The State Security Council, Chaired by His Excellency the Governor Coordinates the activities of OP MESA while the state government and the Lagos State Security Trust Fund provide the required operational equipment/assets and logistics for the outfit. The Council ensures that the three arms of OP MESA function as a unit to ensure the effectiveness of the outfit.

### Areas of responsibility

**Army** – Ikoyi, Mile 2, Badagry, Ikeja, Ogba, Ojo, Ikorodu, Mile 12, Ajah, Lagos Island, Idi-Araba, Agbara and oil pipelines in the state.

**Navy** – Agege, Apapa, Ijora, Ajegunle and some areas of Mile 2 and Oil pipelines and tank farms in Lagos State

**Air Force** – Ikeja, Mushin, Isolo, Apapa Ijaye, Oshodi, and Alimosho including Ikotun, Egbeda, Shasha and its environs

### The Strength/Capacity

**Army** – 15 officers, 150 soldiers and 20 patrol vehicles

**Air Force** – 12 officer, 120 men and 9 patrol vehicles.

**Navy** – 8 officers, 40 men and 11 Vehicles

### Effectiveness OP MESA

OP MESA has continued to provide assistance to the police in the enforcement of law and order especially in their response to distress calls. They have participated in several joint raids of "black spots" where over 800 arrests were made.

They also respond alongside the police to distress calls and have assisted in foiling robberies and arrested 58 armed robbery suspects.

### Challenges/ Requirements

As is usual with such security agencies, OP MESA requires constant maintenance, replacement and even expansion of its assets.

OP MESA is an important component of security in Lagos State and it is necessary to properly equip it for improved efficiency.

### Examples of incident report extracts by OP MESA

1) "On 10 January 2012 at 1948 hours, received informa-



tion of rumour that Hausa community in Agege to be attacked by members OPC. We quickly called Sarkin Hausa, Alhaji Aminu Yaro, to confirm if he heard any such information. Stated he was not in the area at that time, would get back to us asap.

At 2100 hours, Alhaji Yaro called back, we engaged in a conference call with the Danmasanin Agege, Alhaji Mohammed, who promised to arrange with other Hausa leaders at Agege to meet with us. The NAF OP MESA Operations Officer met with them that night at Merikas Road junction. They informed him that the rumour started after the OPC allegedly killed an area boy around Oke Koto earlier that morning. Alleged that the man was killed because he opposed the plans to attack the Hausa community.

NAF OP MESA was immediately directed to conduct show of force around area and deploy there for the night to prevent any attacks on the Hausas by the OPC. Thus, 4 OP MESA vehicles were used for the exercise. The procession started at Capital Road through Alfa Nla to Pen Cinema. Also from Abattoir Road through Oko Oba to Oke Koto; and from Oni Waya road to Merikas Road.

The show of force was very effective and thereafter, the troops pinned down at Oke Koto and Alfa Nla with occasional patrols throughout the night. NAF OP MESA was directed to patrol the same areas the following night and there were no incidents”.

2) “On 19 March 2012, Special Anti-Robbery Squad (SARS) Nigeria Police, Ikeja, wrote to us about an airman who is a suspected armed robber and was being investigated for conspiracy and armed robbery, reported on 7 March 2012, in which an armed robbery suspect arrested at the scene of a robbery with gun, con-

fessed that one of his gang members is a serving Nigerian Air Force personnel. The name of the airman was given as Kingsley Jato, alias ‘Kesolala’, with mobile phone number 08087970726.

From Base Residents’ Data System, it was confirmed that the airman is one NAF07/24064 Lance Corporal Jato Stephen Kingsley, married with a child and residing at Block N1, Flat 28. He is from Isoko in Delta State. The airman was arrested and has since been in detention. We have concluded our investigations and is to be arraigned for trial. Procedurally, he would be dismissed and then handed over to the Police to continue their investigation.

Two count charges of illegal possession of firearms and armed robbery were preferred against the airman. Accordingly, he was summarily tried on the first count of illegal possession of firearms, in which he was found guilty and dismissed from the services of the Nigerian Air Force. As soon as the sentence is affirmed by the Headquarters, Nigerian Air Force, he will be handed over to the Nigeria Police for prosecution. This incident was vigorously publicised in the base to serve as deterrence to others who may be involved in such practices”.
