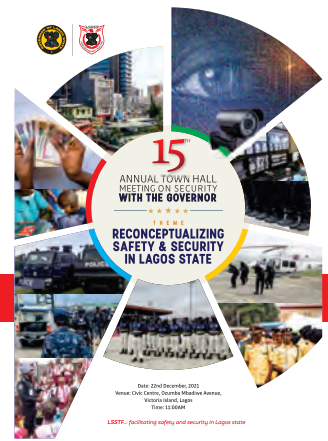

GOVERNOR'S ADDRESS



PROTOCOLS.

Distinguished Ladies and Gentlemen,

Last year when I stood before this gathering, what dominated our discussion was how to respond to the daunting challenges which shook the foundations of the security infrastructure in Lagos State, the Covid-19 Pandemic and attendant security issues faced during the lockdown period, the gas explosion at Abule Ado, and the violent riots that followed the ENDSARS protests.

Of course, in addition to these three outlier challenges that reared their heads in 2020, Lagos has also had to contend with the traditional threats posed by cultism, street gangs, area boys, traffic robberies, kidnapping, land-grabbing, unruly transport operators, and the influx of persons from other parts of the country, fleeing poverty or insecurity in other parts of the country.

At that Town Hall Meeting a year ago, I assured you of the resilience of the people and government of Lagos State; our capacity to rise above the unprecedented disruption confronting us.

Today, one year on, we have made good on our promise to emerge triumphant. We are now, I am pleased to note, firmly on the journey of rebuilding and restoration.

Our gathering today is another indication that we are pressing ahead with the Lagos State Security Trust Fund's vision of "making Lagos the safest, most secure and most prosperous commercial nerve center in Africa". Our theme – Reconceptualizing Safety and Security in Lagos State – clearly acknowledges that we are reviewing our strategies and approaches to ensure we achieve our goal.

This year, the State Government, and the Lagos State Security Trust Fund, with the active support of the private sector, procured and deployed the following security assets for the use of the Nigeria Police Force: Vehicles (180), motorbikes (200), Armoured Personnel Carriers (8), Water cannons (2), cellular communication devices, Level IV bulletproof vests, ballistic helmets, and other items, worth over N3 billion.

We had the privilege of having the President and Commander in Chief of the Armed Forces of the Federal Republic, His Excellency Muhammadu Buhari, commission these assets on June 10, 2021 at the Police College grounds in Ikeja.

In addition to those physical assets, our interventions have included daily fueling of security vehicles and boats, continuous training of security personnel, and routine maintenance and repairs.

The Lagos State Neighborhood Safety Agency has been reorganized to play a more active role in providing intelligence in line with the community policing structure, and to provide manpower support to augment the resources of the police in areas like crowd control, traffic management, and other community engagement responsibilities.

We will continue to train and retrain all enforcement agents of the Lagos State government, while also supporting the federal security agencies to improve their effectiveness.

We have continued to foster engagements with the various security agencies in the state, demanding that they work together to dislodge criminal elements from our state. These engagements have yielded results as we have developed a mechanism in which every agency works in synergy with others to improve the State's security architecture.

We are currently restructuring the 112 and 767 Emergency Call Centre, to enable it deliver on its mandate, and earn the confidence of the people of Lagos State. In line with our vision of a 21st century Megacity, we will deliver a Call Center that is truly responsive. On a related note, we are also progressing on our goal of installing a network of internet-enabled security surveillance cameras across the Metropolis.

Ultimately, the most important contribution we can make to security is what we do to prevent it from being disrupted in the first place. Nowhere is the maxim of 'Prevention is better than Cure' truer than when it comes to Security; it is much easier and less expensive to prevent crime and criminality in the first place than to try to tackle it when it has taken root.

Therefore our focus in Lagos State is on programs, policies and projects targeted at social-economic development: the creation of jobs, economic opportunities and prosperity, and the sustenance of hope in the hearts and

lives of our people. As you all know, despair is one of the greatest existing threats to peace and security. There is no limit to what people can do when they have lost hope about tomorrow.

We are delivering on all our promises, across all the pillars of our THEMES governing agenda. From transportation to health to environment to education and technology, modernization, entertainment and tourism, and to security; we have left no one in doubt as to the depth of our commitment to the emergence of a Greater Lagos.

Our Megacity is a giant construction site: roads, hospitals, schools and classrooms, jetties, a light rail system, housing units, agriculture projects, stadiums, and many more. We are expanding our multi-modal transportation network, training personnel, funding small businesses and startups, automating public processes and systems, and empowering our young people.

Distinguished guests, ladies and gentlemen,

At this point, let me acknowledge the very generous contributions of donors to the Lagos State Security Trust Fund. Without you, we would not be able to do as much as we are doing – your contributions have greatly made a difference. There is however much more still to be done. We need more donors, and more contributions. I am making a special appeal to the private sector and to citizens and other stakeholders in Lagos State, to add your name to the donors' list of the LSSTF. And to our existing donors, I believe there is room for more support.

On our part we will continue to ensure judicious use of the resources you make available. I am glad that transparency and accountability are already baked into the administrative and oversight structure of the Fund; without a doubt this is one of the most well-managed Funds anywhere in this country.

I would like to recognize the very significant and sobering fact that some of our security personnel paid the supreme price during the course of the year. We acknowledge and honor their sacrifice, and we will work to ensure that these sacrifices are not in vain.

The least we can do is to support the families they left behind, and we have done this. It is our prayer that God will continue to keep and bless these families. A case in point is that of CSP Abonde who was killed in the line of duty on September 23, 2021; the LSSTF has since given the sum of N10 million to his family.

As Government, we will ensure that we continue to play the leading role to secure our State. We have demonstrated our commitment in the past, and we remain

resolute in our quest to enhance peace and security, with your support and partnership. We shall never relent.

On that note, let me thank the LSSTF for putting this Town Hall Meeting together, and thank all the attendees and participants for your presence and commitment. A safe Lagos indeed benefits us all in multiple ways as well as the entire country.

For this reason, our sincere gratitude goes to Mr. Babjide Sanwo-Olu, the Governor of Lagos State, for his steadfast support for the Fund. As our Chief Fundraiser, Mr. Governor had personally reached out for donations to the Fund which had advanced the achievement of the huge donation by the Fund to security agencies in the state in 2021. The presentation of these assets by President Muhammadu Buhari had been the highpoint of the activities of the Lagos State Security Trust Fund for 2021. It is also because of the many security challenges that we are proposing that we rethink our response to security in the state hence the theme for today's event:



A REPORT ON THE ACTIVITIES OF THE LAGOS STATE SECURITY TRUST FUND BY THE EXECUTIVE SECRETARY/CEO



saying goes “a problem known is half solved”. It is with this in mind that we are “Reconceptualizing Safety and Security in Lagos State” which is the theme for today's event.

ESTABLISHMENT AND PURPOSE OF THE TRUSTFUND

We should all know by now that the Lagos State Security Trust Fund was established in 2007 to source for resources to improve the operational capacity of the Police and other security agencies operating in Lagos State by providing equipment, logistics, and training. A function the Fund has been carrying out with your support for almost 15 years now using a public-private partnership model as mentioned earlier by the Chairman. In this period, Lagos State and the Local governments/Local Council Development Areas have played a significant role as well as a few private sector partners and individuals.

INTRODUCTION

Good morning and welcome once again to the 15th Town Hall Meeting on Security with the Governor, my task, as always, is to give you a brief on the activities of the Lagos State Security Trust Fund since the last time we met, just over a year ago, on the 4th of December 2020.

To say that security is the number One challenge for us in Nigeria is a cliché. All over the country, we see all forms of security breaches such as armed robbery, kidnapping, terrorism, banditry, suicide, cult-related and other murders, gang/cult violence, public disorder, street crime and extortion, highway robberies, piracy, oil theft, human trafficking, drug pedaling, and so on. Terrorism and banditry which started in the North has slowly crept into some states in the South and is still spreading. We must acknowledge this reality to be able to proffer solutions as the

It is necessary to continue to remind ourselves that the intervention by the Lagos State Government through the establishment of the LSSTF was a result of the inability of the security agencies to carry out their statutory duties due to lack of critical equipment and logistics. These agencies particularly the police, suffered years of resource deficits which almost crippled their operations. Till date, the federal budgetary system has not been able to adequately provide for these security agencies as dictated by the Nigerian constitution. Our security agencies still lack the critical input required for proper planning and assessment of the equipment, personnel, and logistics required to instill law and order and protect lives and property in this teeming, very densely populated and urbanized megapolis of over three hundred separate towns and communities. It is even more worrisome when we do not see any clear plan in sight to deal with this problem especially as much has not come out of the several reforms

that had been proposed in the recent past. In fact, the establishment of the Police Trust Fund drives home the point that there is no alternative to our resource model which in the beginning was to be a temporary solution.

Permit me to state that the Fund was not established to solve all resource challenges of federal security agencies or to take over the financial obligations of the federal government, but to provide critical intervention to enable these agencies operate within acceptable levels of efficiency and effectiveness.

This is why in the over 15 years of our existence it is heartwarming that the Fund has continued to enjoy the support of worthy partners even in the face of unending security, economic, socio-political, and even health challenges and I join my Chairman in thanking our partners for owning our vision and putting their money where their mouth is. We do not take your partnership for granted and we have continued to ensure that our operations are driven by our core values of – Prudence, Accountability, Resourcefulness, and Trust (PART).

OPERATIONS OF THE FUND

The operating philosophy of the LSSTF is to improve general security vis-à-vis VIP/personal security. So every request from security agencies MUST pass this test for it to be considered by the Fund.

The activities and functions of the Fund have grown as the years went by which has necessitated the constant review of its operational structure for efficiency and effectiveness.

As earlier stated, the Fund is a Public-Private Partnership governed by a Board of Trustees which is autonomous and receives no subvention from the state government with an Executive Secretary/CEO seeing to the day-to-day activities of the Fund. For effectiveness, the Fund carries out its responsibility by direct assessment of requests from security agencies. The heads of these agencies are invited to meet with the Board of the Fund to

expatiate on their requests to the extent that it will improve general security and state clear KPIs by which to measure the assistance by the Fund.

The Fund keeps its operations simple with an emphasis on a low-cost structure.

The Fund organizes yearly Town Hall meetings on Security with the Governor primarily to render an account of its activities, present its audit report, and solicit more donations to the Fund. The event is also a unique occasion for the Commissioner of Police, Lagos State Police Command, to present a report on the security of the state to the public while guests can give feedback real-time and also engage the Commissioner of Police and Mr. Governor regarding the security of Lagos State.

The Fund's Vision is – “Lagos: The Safest Most Secure and Most prosperous Commercial Location in Africa” while its Mission is “Facilitating safety and security in Lagos State”

At the level of the Lagos State Security Council, the Fund as a member works closely with the state Government and the Security agencies to strategize and implement the security goals of the state.

It should be emphasized that the Fund does not only provide equipment for security agencies but performs more critical roles such as the maintenance, repair, and replacement of the RRS equipment as appropriate.

Over the years, and to ensure that the Fund is efficiently managed, the Board of Trustees had instituted a governance structure. Board meetings are held every three months but there is an approval system that ensures that memos are sent to all members of the Board via email so requests do not have to wait till the next Board meeting for consideration.

The Fund is managed to be debt free and to be always liquid enough to deal with contingencies, some of which arise from time to time.

Ladies and gentlemen, crime has always been

a part of man's existence as some people will always like to take the easy way not minding the violence and sorrow it inflicts on others. It is the response and proactiveness of our collective resolve that will determine the extent to which these criminals thrive, that is why we must not relent in our decision to fight back to ensure our Lagos is a place where all can achieve their lawful goals without fear.

LAGOS STATE SECURITY ARCHITECTURE AND SCOPE OF INTERVENTION

For the record, the following security agencies and more operate in Lagos State and enjoy the support of the Fund: Lagos State Police Command { 14 Area Commands, 110 Police Divisions, Rapid Response Squad(RRS), 7 Mobile Police units , SWAT Unit, Explosive Ordinance Dispersal (EOD), State Intelligence Bureau (SIB), Ops Attack, Counter Terrorism Unit (CTU), Traffic Unit, Marine Police, Mounted Police Unit, Lagos State Taskforce on Environmental and other Offences (Taskforce)), Airport Police Command, Railway Police Command, Army- OP MESA and Quick Response Group (QGR), Navy- OP MESA and sea patrols, Air Force- OP MESA, State Security Service (SSS), Nigeria Correctional Service, Nigeria Immigration Service, National Drug Law and Enforcement Agency (NDLEA), Lagos State Neighborhood Safety Agency (LNSA), Federal Road Safety Corps (FRSC), Nigeria Security and Civil Defense Corps (NSCDC), Lagos State Environmental Sanitation Corps (KAI), Lagos State Traffic Management Authority (LASTMA), Vehicle Inspection Service (VIS), Lagos State Fire Service, Lagos State Emergency Response Agency (LASEMA), LASEMA Response Unit (LRU), National Agency for the Prohibition of Trafficking in Persons (NAPTIP).

Still keeping things in perspective, please note that about 70% of the equipment and logistics used by most of these security agencies, especially for the Police RRS, and OP MESA (Army, Navy, and Air Force) were provided through the Lagos State Security Trust Fund.

The peculiarities of the security situation in Nigeria have necessitated the involvement of the military in internal security so it is

common to find the military providing assistance in combating armed robbers, street gangs, and kidnappers.

As all these sister agencies continue to play their roles in assisting the police in internal security the scope of intervention of the Fund continues to expand. This makes the Fund's job of targeted interventions even more complex as we continue to identify KPIs that help determine our level of support and impact as we do not control the level of deployment or usage of these assets.

According to the Policy and Advocacy Centre (supported by the MacArthur Foundation) "The total amount allocated to Police Formations and commands (in Nigeria in 2020) is N 403,709,451,000 (Four Hundred and Three Billion, Seven Hundred and Nine Million, Four Hundred and Fifty-one Thousand Naira). This amount is broken down to N 389,200,192,849 (96.4%) for recurrent expenditure and N 14,509,258,151 (3.6%) for capital expenditure". Out of the capital expenditure budget, N 572,164,887 was earmarked for motor vehicles and trucks. By simple arithmetic, if one Toyota Hilux pickup truck costs conservatively N19 million in 2020 only 30 of these trucks can be purchased based on this budget for the entire police force in 2020!

This, ladies and gentlemen is our reality. There is a serious resource problem that appears to be unending. We cannot continue doing the same thing and expect a different result!

However, we are not perturbed as Lagos has risen above the very many challenges that had faced us in the past with resilience and determination that is second to none - the several political and economic unrests, bomb blast, plane crash, ocean surge, gas explosions, petrol tanker explosions, Polio, Ebola, and many more assure us that together there is nothing we cannot surmount.

After all, Lagos is still the socio-economic and cultural hub of Nigeria, the go-to place for opportunities, and now a safe haven to many. We are arguably the 5th largest economy and most cosmopolitan city in Africa.

There is no doubt in my mind that with all of us playing our part under the able leadership of the Lagos State Governor, Mr. Babajide Sanwo-Olu the future is bright.

THE FUND'S ACTIVITIES SINCE DECEMBER 2020 TOWN HALL MEETING

In the last year, the Fund with the Lagos State Government, the Local Governments/Local Council Development Areas, private sector organizations, and individuals have been able to provide 183 vehicles fully fitted with communication and security accessories, 200 motorbikes, 8 Armoured Personnel Carriers (APCs), 2 Water cannons, 167 Push-to-talk on Cellular communication devices (an enhanced radio communication on mobile data infrastructure), 1000 Level IV bulletproof vests, 1000 ballistic helmets, 15,000 teargas canisters with dispensers, Uniforms, 1000 Ballistic fragmentation vest, etc. for security agencies in the state.

In addition, the Fund carried out quarterly routine service on 322 security vehicles, and 42 Marine Police boat engines, while providing other consumables as 522 tyres of various sizes, 180 batteries of various specifications, daily fueling of the RRS vehicles, the weekly and monthly fueling support for the Marine Police, the Navy and the Air Force.

In the course of the year, some of our security personnel paid the supreme price for our safety and the Fund paid Fifteen Million Naira (N15,000,000.00) in support of two families affected apart from what the state government had done on its own.

The Fund carried out full refurbishment, which includes replacement of gear systems, brake systems, full upholstery, suspension systems, full body painting, replacement of complete engines on 37 security vehicles for security agencies. This is to extend the useful life of these assets especially as the cost of replacement is prohibitive and also to immediately restore some of the assets destroyed during the riots that followed the

EndSARS protests. Other repairs and maintenance were carried out on another 94 vehicles.

To achieve the above, the management of the Fund had reached out to its partners and prospective donors through personal contacts, letters, newsletters, social media sponsored adverts on Instagram, Facebook, and Twitter while the Board of Trustees of the Fund leveraged on their personal networks to reach out for donations. Mr. Governor also contributed immensely to the effort and on behalf of the Board and Management of the Fund, I wish to thank him for the great work and leadership in ensuring that the Fund was able to make critical interventions in 2021.

The Fund has continued to forge healthy relationships with security associations, Chambers of Commerce, market associations, and even embassies to seek opportunities of collaboration not just in donations but also in the development of policy and industry security framework/standards to improve the general security architecture in the state.

It may also be important to state that the 2021 interventions by the Fund to security agencies have been across board to reach almost all frontline and support security agencies so that the entire system is galvanized for improved service delivery. So, you will find that the activities of the Federal Road Safety Corps have been boosted by the Fund including that of the National Drug Law Enforcement Agency (NDLEA), the Fire service, the Railway Police Command, Nigerian Correctional Service, Nigeria Security and Civil Defence Corps (NSCDC), and the Nigeria Immigration Service (NIS). We also supported homegrown sister agencies such as Lagos State Traffic Management Authority (LASTMA), Lagos State Emergency Management Agency (LASEMA), Lagos State Neighbourhood Safety Agency (LNSA), etc. It is pertinent to note that these agencies also play critical roles in the safety and security of the state.

The state still did not witness any bank robbery in 2021, although there were reported cases of street robberies and kidnappings. I am sure the Commissioner of Police, Lagos State Police Command, would shed more light on the police response to these issues and more in his report on the security situation in the state.

At this juncture, one can liken the Lagos State Security Trust Fund to a CLUB or an ASSOCIATION while the following entities – the organized private sector such as banks, other financial institutions (e.g. insurance companies), hotels, private security organizations, market unions, associations, etc., are its members who are expected pay up their subscriptions/dues as and when due to keep the Club running!

Bearing in mind that the activities of these categories of establishments are dependent on a secure and safe environment. The Fund beyond any doubt has continued to play a critical role in this regard and it is expected that on-lookers would reciprocate this gesture by giving their donations (cash or kind) to keep the Fund running.

I want to commend our security forces for their resilience, dedication, and patriotism in fighting crimes despite the devastating blow on our security architecture. You have not relented, even when we can attest to the deplorable state of some of your facilities that were destroyed. On the side of the Government and the Fund, a lot has been done to restore your facilities and create a good working environment for your operations. Be assured of our commitment to providing the critical needs of security agencies as we expect that security agents will also put in their very best to deliver a crime free state for our residents as a mark of appreciation for the support they receive from the state. Our collective efforts will continue to make Lagos the safest state in the Federation despite her numerous challenges.

FINANCES OF THE FUND AND CHALLENGES

From January 2021 to date, the Fund received a total of One Billion and Forty Million Naira Only (N1,040,000,000.00) in donations out of which Seventy Million Naira (N70 million) were pledges made in previous years but redeemed in 2021, while the Expenditure of the Fund was N1.16 billion.

Although every donation is as important as the other, especially in terms of buy-in I want to particularly mention that of Zenith Bank and the role of Mr. Jim Ovia in ensuring this happens year on year. I would also want to mention the organizations and individual(s) that have made donations in 2021 to emphasize the fact that only a few worthy partners have continued to carry the responsibility of supporting security agencies to keep us all safe - Zenith Bank Plc., KC Gaming Networks (Bet 9ja), Winner Golden Chance Ventures, Mr. Yemi Idowu, First City Monument Bank (FCMB), Council of Obas & Chiefs of Lagos, Chief Leonard Nnamdi Ekeh (Stan Ekeh), Wema Bank Plc., Leadway Assurance Coy Ltd., Ports & Cargo Handlings Services Company, STL Trustees Limited, Emadeb Energy Service Ltd., Association of Licensed Private Security Practitioners of Nigeria, Lagos Ferry Services Company Ltd., and Lagos State Lotteries and Gaming Authority. We once again use this medium to appeal to everyone particularly the corporate world to play their part. It is pertinent to state that in 2021 only three (3) banks - Zenith Bank, FCMB, and WEMA Bank made donations to the Fund.

As always, the Fund's accounts are audited by external auditors and the extracts of Y2020 audited financial statements have been published in the Annual Town Hall Meeting Brochure (this document) while the full audit is on the Fund's website. Be assured that Y2021 accounts will also be audited and published likewise as we have continued to do since the inception of the Fund.

Ladies and gentlemen, the challenges facing the Fund in carrying out its statutory responsibility are daunting. There is donor fatigue considering that only a few organizations are carrying the weight of providing critical equipment, training, and logistics for the Police and other agencies in the state which has now been further complicated by the harsh economic situation brought about by the effects of the COVID-19 Pandemic measures.

The high cost of equipment required for security is another issue especially for the technology-related equipment such as good quality drones, CCTV cameras, trackers, etc. No doubt security is expensive.

The increase in the foreign exchange rates in the country is another serious challenge. Another big issue is the disruption in the global supply chain such that it may not be easy to get goods required even when the money is available to purchase them. This is a further consequence of the COVID-19 pandemic as global supply chains and shipments slowed, causing worldwide shortages and affecting consumer patterns. There had been further disruptions as factories are forced to close in different parts of the world owing to the response of various countries to the surges in their COVID-19 infection rates. This has not only increased the cost of goods and shipping but also made goods scarce.

The frequency of damage to security assets is another issue. Security assets suffer a very high rate of attrition especially when they are not sufficient. So, while a private car is parked when not in use by the owner, security cars are often in use almost all the time by different users, and even at the end of a shift, another team is assigned the vehicle for use. Apart from not having any idle time, there is difficulty in accounting for the damage on vehicles because they are used by several people in quick succession.

The destruction of security assets during the riots that followed the EndSARS protests was

large-scale. Noting the fact that the assets were not enough even before they were destroyed puts the situation in better context as to the scale of the problem.

Notwithstanding these challenges, the Fund will not relent in its resolve to impact positively on the security architecture of the state. We shall continue to move on, even with the several unanswered phone calls, unacknowledged letters, text messages and emails to prospective donors. Even with the long waiting hours to see a potential donor, with the repeated cancelation of appointments which makes nonsense of our scheduled plans, we will continue to move on. We shall follow up with every potential donor, we shall not relent for the future and lives of our children and loved ones depend on it. We call on corporate citizens and individuals to donate voluntarily to the Fund. Although the provisions of the law establishing the Fund in Section 9 (1e) of the LSSTF Law 2007, created an avenue for levies to be imposed as done by the Federal Government for establishments like the Industrial Training Fund, Tertiary Education Trust Fund (TETFUND), Police Trust Fund, etc. but 15 years down the line this window is yet to be activated.

NEEDS ASSESSMENT

Ladies and Gentlemen, truth be told, the needs of security agencies are endless as they are expected to be prepared for every single possible crime scenario. Often most people do not see how simple solutions to a problem such as providing sniffer dogs creates a whole new expenditure matrix such as housing, feeding, training, health care and even providing special protection details for the dogs from drug barons who would seek to kill them. Keeping these dogs alone is a very expensive endeavor but the K-9 unit is not too advanced to be included in our security architecture in the state.

Our security agencies require advanced training, more equipment that would support an intelligence-led approach to crime prevention (drones, trackers, scanners at city gates, gunshot detection devices) more non-

lethal weaponry. To fully kit one policeman with uniform, taser, tactical gear (light, knife, jacket, belt, gloves, knee, shoulder, ankle, and boots) bulletproof vest, ballistic helmet, tear gas, push-to-talk on cellular communication equipment, rain gear, etc., will cost at least Three Million Naira (N3,000,000.00) per officer. Hence to kit 33,000 police officers in Lagos will cost about Ninety Nine Billion Naira (N99,000,000,000.00). This is our reality if we truly want a highly motivated, and fully equipped police force in the State.

It is clear that we are just scratching the surface but like it is asked “how do you eat an elephant?” - one bite at a time. Understanding the problem is key to proffering a solution. The Fund has about fifteen years of experience and knowledge in objectively studying the problem and we can provide the necessary guidance to reach the Promised Land. What we need is finance. It is as simple as that.

CONCLUSION

Insecurity is spreading from the north to the south and we need to be ready. We need to build on our capacity to deal with future challenges. As with the Theme of today's event, we need to “Reconceptualize Safety and Security in Lagos State”. Our thinking must be from a point of catering for the well-being of the entire populace. Making people realize they can achieve all they can imagine and providing the support they need to succeed. This thinking goes beyond just the provision of hard security architecture but also ensures food security, health security, educational security, social security, economic security, political security, and so on. We must give Lagosians the impetus to want to defend their state knowing full well that if the state sinks, they sink. We need to create citizens of Lagos who will believe in the Lagos dream and will drive or die with it.

The Lagos State Government has started in this direction, but with a population of over 21 million people, it is a bit difficult to feel the impact. This is why the government continues to seek selfless partners who understand the

dream and are willing to lay the foundation for what they may not benefit from but that will ensure that their lineage will always succeed even if the family wealth is lost somewhere along the way.

This is the paradigm shift from self-actualization to societal development built on solid and sustainable pillars.



A REPORT ON THE ACTIVITIES OF LAGOS STATE POLICE COMMAND FROM DEC. 2020 TO SEPT. 2021

INTRODUCTION

I am indeed highly delighted to share the joy of today's occasion with you all, as I deliver a report on the activities of Lagos State Police Command from December 2020 to September 2021.

There is no denying the fact that, there were huge security challenges immediately after the October 2020 #ENDSARS protests which disrupted social and economic activities of the State. It is however pertinent to state that, with various proactive measures put in place and the support from all stakeholders here gathered, the tension occasioned by the activities of the hoodlums have been subdued.

Particular mention is the support received from the Inspector-General of Police, IGP Usman Baba Alkali, NPM, fdc, for his leadership styles which created the enabling working environment and platform to discharge our statutory duties without let or hindrance. Also, of note is the immense support received from the State Government led by Mr. Babajide Olusola Sanwo-Olu and the Lagos State Security Trust Fund (LSSTF).

The swift reaction of Mr. Governor to meet with the Officers and men of the Command: compensate personnel who suffered loses: quick rehabilitation of Police stations vandalized/burnt and replacement of patrol vehicles burnt during the protests really contributed in reinvigorating the shattered morale/psyche of the personnel in the Command. The resultant effect was their renewed commitments to duty in the fight against crimes and criminalities, which has given way to a new dawn of peace and tranquility in the State.

Other logistic support collectively received from the State and LSSTF by security agencies during the period under review are:

- 150 Double Cabin Vehicles
- 30 Saloon Patrol Vehicles
- 1,000 Ballistic Vests
- 1,000 Ballistic Helmets
- 1,000 Handheld Police Radios/Walkie Talkies
- 200 Security Patrol Bikes
- 2 Anti-riot water cannon vehicles
- 2 Armored Personnel Carriers (APC)
- 4 High Capacity Troop Carriers.
- Office furniture and other ancillary resources

The Command will continue to rely on logistics support from the State Government, LSSTF and all other stakeholders in order to sustain the current tempo against crimes and criminalities in the State.

CRIME SITUATION IN LAGOS STATE

The distinctiveness of Lagos State as the economic hub of the country and sub-Saharan Africa, coupled with the aftermaths of the #ENDSARS protests, placed enormous security challenges at the doorsteps of the Command. However, with the synergy with other security agencies and the implementation of various proactive and intelligence driven security strategies, incidents such as, armed robbery, murder, cultism, kidnapping, rape, defilement, terrorism, fraud, car-jacking, bank robbery, trans-border crimes, civil unrest, violent protests and targeted attacks on Government facilities by aggrieved groups were brought to the barest minimum.

While pockets of such cases recorded were diligently investigated with the suspects arrested and prosecuted accordingly. Also, incidents of robbery in traffic being perpetrated by miscreants have been given maximum attention.

Remarkable successes were recorded in other incidents, particularly, kidnapping which recently reared its ugly head in the State.

Victims in the 4 incidents recorded in the Command, at Langbasa, Festac, Gowon Estate and Imota have been rescued and reunited with their families. In one of the encounter with the kidnapers at their hideout in Imota, 2 of the hoodlums were fatally injured while one other was arrested. Likewise, atrocities being committed by hoodlums with the use of motorcycles are being frontally confronted.

Apart from full enforcement of the Lagos State Traffic Law banning the use of commercial motorcycles (OKADA) in some selected areas, the Command has intensified raid on all their hideouts in order to keep the heat on them. While motorcycle convoy patrols emplaced to monitor hoodlums attacking motorists during traffic snarl, particularly during peak periods has greatly curtailed the menace.

I wish to reiterate that, the hydra-headed menace of cultism in the State has nosedived with the full implementation of the provisions of the newly enacted law on cultism and allied matters by the State Government. The law did not only prescribe punishments for the culprits, it also outlined sanctions for the parents of the suspects, landlords and any other persons that harbour them or allow the use of his or her facilities by the cultists.

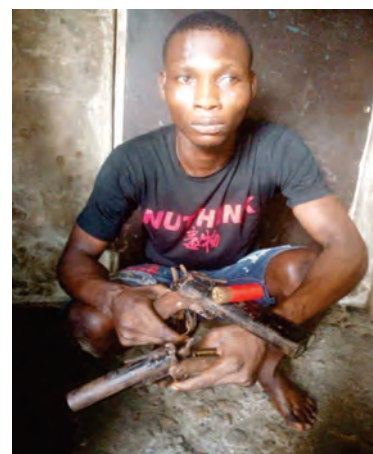
The Command is fully aware of the current precarious security situation across the country, and this has necessitated continuous review of security strategies employed in policing the State. The South Western States, including Lagos, is having a fair share of these security breaches, with the continuous agitation for Oodua Republic by some Yoruba separatist groups.

A total of twenty-four (24) of such groups that are allegedly clandestinely planning subversive activities to cause mayhem in the South West, especially Lagos are closely being monitored and proactive measures being taken to forestall this.

Similarly, uncovered threats to attack soft targets in Lagos by some other disgruntled associations are equally in the radar of our intelligence gathering and strategies are being put in place to neutralize their activities.

HIGHLIGHTS OF ACHIEVEMENTS RECORDED DURING THE PERIOD

ARREST OF SUSPECTED ARMED ROBBERS/RECOVERY OF ARMS & AMMUNITION



On 29/11/2020 at about 1200hrs, one Sunday Mustapha 'm' was arrested at Ibeju Lekki for possession of one locally made

double barrel and single barrel short guns with one unexpended cartridge. The suspect is alleged to be one of the hoodlums that participated in the burning of Elemoro Police Station during Endsars protest.



On 26/01/2021 at about 1210hrs, at Oluwatoyin Street, Shasha, one Tarry Patrick 'm' age 43yrs, Dennis Ejiofor 'm' age 57yrs and Chukwuemeka Obeleke 'm' age 47yrs broke into a vehicle, a Toyota Camry Car with reg. No. MUS 395 FK with a master key and stole cash sum of Five hundred thousand Naira (N500,000.00). The suspects were later arrested, and the master key recovered with the exhibit. The suspects have been charged to court.



On 17/04/2021 at about 0030hrs, one Precious Peter 'm' was arrested at Access Bank, Ilasan Branch, while attempting to break into the Bank's ATM. Two (2) cutlasses; One chisel; and Two (2)

fire extinguishers were recovered from him. Suspect has been charged to court.



On 13/05/2021 at about 1105hrs, one Henry Chimereze 'm', Charles Atri 'm' and Basiru Muhammed 'm' were arrested at

Festac, Mile 2 area. One locally made single barrel gun, Four (4) unexpended cartridges, Sum of Two million, six hundred and thirty-one thousand Naira (N2,631,000.00), Eight (8) booklet of Lagos State Government consolidated duty ticket, One Toyota Corolla Saloon car with Reg. No. GGE 27 GB and one Lexus LS 350 Saloon car with Reg. No. AAA 41 GS were recovered from them. Suspects have been charged to court.

TRAFFIC ROBBERS



On 7/02/2021 at about 1450hrs, one Yusuf Sabitu m' age 20yrs was arrested at Apongbon bridge, Lagos Island while robbing innocent

people in the traffic on top of the bridge. One locally made pistol; and One unregistered Bajaj motorcycle were recovered from him. Suspect has been charged to court.

ARREST OF DRUG PEDDLERS AND RECOVERY OF PSYCHOTROPIC SUBSTANCES



On 28/01/2021, one Folami Oluwadamilare 'm' and Desire Chukwu 'f' were arrested at Meiran with

Some quantities of weeds suspected to be Indian hemp were recovered along with a locally made single barrel pistol. Suspects have been charged to Court accordingly.



ARREST OF SUSPECTED MURDERER

On 16/06/2021, at about 1230hrs, one Chidinma Adaora Ojukwu 'f' and six others

Conspired and Murder one Michael Usifo Ataga 'm' aged 50 years by stabbing the deceased to death with a kitchen knife, while sleeping at No. 19, Adewale Oshin Street, Lekki Phase 1, Lagos. The prime suspect, Chidinma Adaora Ojukwu 'f', and one other accomplice have been charged to court.

ARREST OF BANK HACKER OVER N1.87 BILLION FRAUD



Operatives of Lagos Command arrested one Salau Abdulmalik Femi, the Kingpin of a syndicate that specializes in

hacking into the Server of Banks and corporate agencies. The hacker, who displayed exemplary mastery of the cyber environment, was arrested after he hacked the Flex-Cube Universal Banking System (FCUBS) of a First-Generation Bank. Using a software application, he created a fictitious credit accounts totaling One Billion, Eight Hundred Thousand Naira (N1,868,900,000.00) on the accounts of three (3) of the Bank's customers and successfully consummated debits (outflows) amounting to Four Hundred and Seventeen Million, Five Hundred and Forty-Two Thousand Naira (N417,542,000.00)

through Internet Banking transfers to other Banks. While acting swiftly on petition from the Bank; contacted the Central Bank of Nigeria (CBN) and Deposit Money Banks (DMBs) whose customers were beneficiaries of the fraudulent funds and was able to salvage a substantial amount. Items recovered from the suspect includes: Apple Laptop and iPhone; while he and operators of BDCs used to launder the monies were arrested and thereafter transferred to the Special Fraud Unit (SFU) for further discreet investigation.

Conversely, the command encountered some challenges in the fight against crimes and criminalities in the State. Notable among these is the dynamism in the pattern of crime committed by the hoodlums, particularly; internet fraud, phone hacking, phony job offers, one chance robbery, etc. which are alien to conventional crime. Consequently, the command is evolving new strategies to combat these crimes. Also, the introduction of scientific aid and acquisition of modern equipment in investigation of cases, has thrown major challenges on the command for the training of personnel to handle such. It is a known fact that, the equipment neither has eyes nor ears. Therefore, it must be operated by officers and men with requisite knowledge in order to realize the intended objectives.

#ENDSARS ONE YEAR ANNIVERSARY PROTEST

On 20/10/21 between 0800 hours and 1000 hours, promoters of #ENDSARS protest came out in their vehicles in large numbers in a motorcade to carry out one year #ENDSARS anniversary protest at Lekki Toll Gate, notable among the protesters are one Debo Adebayo, known as Mr. Macaroni, Folarin Falana, son of Mr. Femi Falana SAN and the #ENDSARS lawyer, Bar Adeshina Ogunlana. The protest was carried out peacefully without any threat to security apart from the obstruction of traffic experienced by commuters during the period.

However, immediately after the protest, hoodlums took advantage of the traffic gridlock occasioned by the long convoy of the protesters vehicles to come out and attack law abiding citizens and the policemen mobilized to the venue for security purposes responded to the challenge accordingly. Thirty-four (34) of the suspects were arrested while other miscreants were dispersed with minimum force and normalcy restored to the area. Two (2) cutlasses, one hammer, one jack knife were recovered from the hoodlums.

One Shina Esun 'm' a Man O' War personnel, attached to LCC Limited, was stabbed in the stomach by the hoodlums and was rescued to hospital. The suspects were charged to Lagos mobile court accordingly. Two of the suspects pleaded guilty and were convicted and fined #10,000; thirty(30) pleaded not guilty and were granted bail of #20,000 with one surety in like sum; one was discharged and acquitted while one who was found with the dangerous weapons and confessed to commission of the crime was referred for further investigation.

UPDATE ON 2020 POLICE RECRUITMENT

The selection process for recruitment of Lagos State indigenes into the Nigeria Police Force continued with the Computer Based Test (CBT) at WAEC training ground, Ogba between 29th and 30th October, 2021. Successful candidates are expected to undergo medical fitness before commencement of actual training later in the year.

COLLAPSED BUILDING AT IKOYI

On 01/11/2021 at about 1400 hours, a block of flats of a 21-storey building under construction, located at #44, Gerrard Road, Ikoyi collapsed and trapped several Engineers, workers, artisans and other visitors, including the owner, one Femi Osibona 'M', of Mosley Road, Sharon Apartment. Based on the report, teams of policemen, National Emergency Management Agency (NEMA), Lagos State Emergency Management Agency (LASEMA), Firefighters and other emergency responders were swiftly mobilized to the scene for rescue operations. So far, 15 of the victims were rescued alive with

severe injuries while 44 others were brought out dead from the debris.

EMBER MONTHS OPERATION

In view of the rise in the commercial and social activities and the expected rise in crime rate within these periods, the Command has emplaced strategies to curtail criminal activities and ensure security of lives and property of all residents in the State. Adequate manpower have been deployed for traffic control duties at the areas notorious for traffic gridlock also robbery in traffic by hoodlums is being given maximum attention.

CHALLENGES/CONSTRAINTS

However, despite the massive contributions of the LSSTF to the Command, dearth of patrol vehicles remains a great challenge; many vehicles attached to the divisions have become rickety and unserviceable due to old age and over usage. Another challenge is the frequent breakdown of the Command's communication system, thus, hindering operations and anti-crime activities. Currently, the Command has two repeaters bases situated at NITEL building, Marina and Alausa. The one at Marina is too old, develops faults at random and makes radio communication extremely difficult.

NEEDS/WAY FORWARD

As a remedy, the following are the urgent logistics need of the Command:-

COMMUNICATION:

- Three (3) Motorola MTR2000 Repeaters, 100w heavy duty mood with cooling system;
- Three (3) 9DB gain heavy duty Omni-directional Antenna for MTR2000 repeater;
- Three (3) 100m Heliac low loss cable
- One (1) 3db gain Antenna for the existing base station in Maroko Police Station
- Four (4) 1.5 KVA Inverter (Maroko and Marina)
- Eight (8) 200mAH Heavy duty Lead Alkaline battery (Maroko, Marina and 2 other new repeaters)
- Three (3) 'U' Bracket for Antenna Installation

- Three (3) Installation (turning and Programming)
- Four Thousand (4,000) walkie-talkies;
- One hundred and fifty (150) Base Sets;
- Four (4) new repeaters, each with 60KVA generator and back-up batteries

PATROL VEHICLES/MOTORCYCLES:

- 200 patrol vehicles, equipped with communication gadgets;
- 5 lorries (troop carriers);
- 5 heavy duty towing vehicles.

Other logistics requirements include arms and ammunition, riot gunners, smoke pistols, hand grenades, tear gas canister, thunder blasts, bullet proof vests, ballistic helmets, respirators, etc.

CONCLUSION

It is pertinent to place on record that, the suspects in all the cases mentioned above have been charged to courts of competent jurisdiction accordingly.

The Command earnestly appreciates the Government and the good people of Lagos State for their continuous and unflinching support, which has momentarily assisted the Command to record the modest feats highlighted in this presentation. The Command is using this medium to implore all Lagosians, to continue to be law abiding, particularly, obey all traffic rules and regulations, including, traffic lights.

All hands are on deck to ensure that the forthcoming yuletide season is hitch-free.

The officer and men of the Lagos State Police Command under my watch, will not rest on our oars towards providing water-tight security, to keep the State safer at all times.

The officers and men of Lagos State Police Command wishes to express their profound gratitude and appreciation to His Excellency,

the Executive Governor of Lagos State, Mr. Babajide Olushola Sanwo-Olu, the Lagos State Security Trust Fund (LSSTF) and the good people of Lagos State, for the provision of the enabling environment and requisite tools to fight crime and criminality in Lagos State. This gesture has made Lagos State Police Command a model for other State Commands in the country to emulate.

Finally, in order to facilitate easy communication, between the Command and members of the public, dedicated lines are made available for the public to contact police on all issues relating to security in the State.

The Command will not relent in its efforts to consolidate on the achievements so far recorded and will most highly appreciate if these critical crime fighting equipment are provided to enable it improve on the successes so far recorded in its dogged fight against crimes and criminalities.

SUMMARY OF ACHIEVEMENTS FROM DECEMBER 2020 TO SEPTEMBER 2021

From the summary of incidents recorded in the Command as highlighted above, out of the 228 robbery incidents carried out by the hoodlums within the period, 206 were foiled while 22 were successful with 1,124 suspects arrested in connection with the crimes. 1,034 among the armed robbery suspects arrested have been charged to court while others are still under investigation. In the same vein, 22 cases of cultism and arrest of 390 cultists were recorded during the period. 149 of the cultists have been arraigned before the court while investigation into the cases involving others is yet to be concluded.

A total number of 243 murder cases were recorded with the arrest of 215 suspects.

210 of the murder suspects were charged to court while investigation is ongoing on other cases.

206 different arms and 475 assorted ammunitions with 168 other dangerous weapons and cudgels were recovered during the period.

4,029 social miscreants arrested and charged to court were convicted accordingly, with punishments ranging from fine, communal service to imprisonment awarded to them

A total of 8,483 motorcycles were impounded for plying restricted routes, while 4,406 vehicles were contravened for commuting on BRT corridor.

On children and gender related matters, 381 cases of rape/defilement, domestic violence, sexual harassment and indecent assault were recorded with 345 suspects arrested.

Out of the suspects arrested, 311 have had their days in court while others are still under investigation.

A BRIEF ON THE ACTIVITIES OF THE RAPID RESPONSE SQUAD (RRS)



The Rapid Response Squad (RRS) is a section of the Lagos State Police Command charged to respond speedily to emergencies within Lagos State. It was initially referred to as 'Operation Sweep' during Colonel Buba Marwa Military administration which was a joint Army, Air Force, and Police Crack team established to tackle crime at that period. The formation has gone through various phases of restructuring and reorganization giving rise to a culture of discipline and efficiency.

The RRS comprises of about two thousand officers equipped by the Lagos State Security Trust Fund (LSSTF) through the donations and contributions from Public and Private Organizations including well-meaning individuals. Motorbikes, Patrol Vehicles, Helicopters, Gunboats, Ballistic Helmets/Bulletproof Vests, Raincoats/Boots, etc. were provided for the RRS to enable them significantly reduce the crime rate in the State. The LSSTF has remained the “unseen” hand behind the RRS.

Within the period of October 2020 to September 2021, the RRS has successfully accomplished the following:

CRIME PREVENTION

As prevention of breakdown of law and order remains the key responsibilities of the Police, the men of the RRS ensures that this responsibility is adequately carried out, by institutionalizing a 24hour patrol of the metropolis and daily strategic positioning of Patrol Vehicles, Motorbikes and Armored Personnel Carriers (APCs) in various parts of the State to register security presence, thereby discourage criminal activities.

CRIME INTERVENTION

In the period under review, the dominant achievements of the Squad remains the speedy response to emergencies and distress calls in all parts of Lagos State which has assisted in the maintenance of order, saved

lives and property. The continuous injection of fleet of Patrol Vehicles, APCs, Motorbikes, and other operational equipment to the Squad, has tremendously assisted the RRS in complementing the efforts of the Command in crime fighting and prevention in the State.

While officers of the RRS understand that criminals are always looking for any opportunity to wreak havoc especially during civil disorders, operatives swiftly step to restore orderliness. Some of the situations that occurred in the period under review are Mile 12 (cult clashes), Ketu (Civil unrest), commercial motorcyclists unrest at Agbado/Agbado – Oke – Odo, Ikorodu (Cult Clash), Oke - Odo Market (hoodlums/marketers fight) etc. Stemming from these exercises, 29 hoodlums were arrested.

CRIME BUSTING AND ARRESTS

The response of security operatives to distress calls and credible intelligence leads resulted in the arrest of suspected criminals involved in various crimes such as burglary, pickpocketing, robbery, fraud, internet scam, cult clashes, etc. Some of the major arrests made include:

- i. Arrest of two robbery suspects at Akowonjo Road in Alimosho in a Lexus 4WD (LSD 666 GK).
- ii. Arrest of, two Robbery suspects at Oshodi leading to the recovery of locally made pistol
- iii. Arrest of two notorious traffic robbers at Ojota and tipper garage, Ketu
- iv. Arrest of a suspect who peddles Tramadol, Codeine, “Manpower” and other drugs at bus-stops in Lagos during the day and serves as a security guard at night.

v. Operatives of the RRS carry out joint raids with several Police divisions such as Idimu, Ketu, Afonka, Alagolo, Ikotun, and Ijede of criminal hideouts and arrest of suspects.

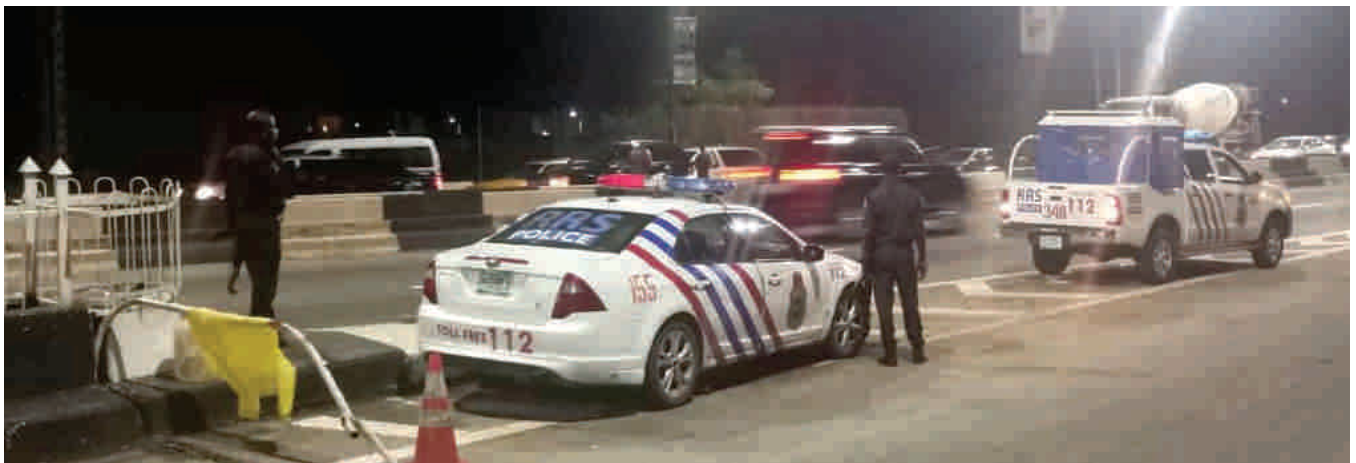
SUPPORTIVE SERVICES AND ASSISTANCE TO LAGOSIANS:

The RRS operatives makes it an obligation to render selfless services to Lagosians where necessary, such assistance comes in form of helping road users with faulty cars, assisting motorists who run out of fuel, reuniting missing children with their parents. An example of such assistance is when a team of RRS operatives on patrol of black spots around Marketing B/stop, Ogba-Ijaiye, Lagos around 10:45pm, assisted a man in his late 60s, whose Honda Pilot vehicle developed an engine problem.

Also the RRS has on the approval of Governor, Mr. Babajide Sanwo-Olu embarked on an anti-crime campaign in secondary schools in Lagos State as a way of reducing crime related activities such as cultism, drug abuse and addiction as well as violent related crimes involving secondary school students in Lagos State.

In conclusion below is a summary of some of the activities of the formation in the period under review:

- (i) Fire incidents attended to = 42
- (ii) Fire incident victims rescued = 34
- (iii) Accidents incidents attended to = 20
- (iv) Accident victims rescued = 92
- (v) Civil disturbance/ fight prevented = 46
- (vi) Suspects arrested with substance suspected to be Indian hemp = 5
- (vii) Miscreants arrested = 170
- (viii) Vehicles arrested breaking state laws = 267
- (ix) Vehicles recovered = 3
- (x) Recovery of Guns = 6
- (xi) Ammunition recovered = 20



A BRIEF ON THE ACTIVITIES OF THE MARINE POLICE

INTRODUCTION

The Marine Police was established in Lagos, Nigeria in the year 1891 and was named “Night Patrol Team”. This is a division of the Nigeria Police saddled with the responsibilities of basic operational duties such as Anti-Smuggling Patrol, Anti-Vandal, Anti-Piracy, Anti-Militancy/Kidnapping Operations, Enforcement of Ports, Harbor and Shipping Acts, Surveillance, General Anti-Crime duties.

The Marine division generally conducts security combat and anti-crime operations in territorial inland waters (measuring from the inward limit of the coastal waterways from the fairway buoy), Ports and Harbors. The basic and ancillary powers and authority of the division are from the constitution of the Federal Republic, Police Act and various other Acts and Legislations.

THE DEPARTMENT'S ACTIVITIES

The strategic positioning of Armoured Gunboats, Anti-Sea Piracy boats, Back-up and other Patrol Boats in different strategic locations within the Lagos State waterways / creeks and at entry points of Lagos have been

proactive measures taken by the Unit which has relatively reduced crime especially in Epe, Ise, Badagry, Ijede, Ikorodu, Apapa, Lagos Breakwaters, Festac, Egbin Power Station, etc., criminality and other waterborne crimes, ranging from Militancy, Kidnapping, Sea piracy, etc. that were formally been predominately recorded in the aforementioned areas, have been stabilized with extreme low or no crime recorded.

Some of the division's outstanding feats are presented below:

The division successfully rescued victims of boat mishap including responding to a distress call received from a boat operator in Gbaji Badagry, Lagos that a speed boat with inscription “ONLY GOD”, fitted with 115HP Yamaha Engine conveying Twelve (12) passengers from Gbaji Badagry to Liverpool, Apapa collided with an oncoming speed boat at Ibashe waterfront. On the receipt of this information, a gunboat and a back-up boat from the division was immediately deployed to the scene of the incident. The twelve (12) passengers were rescued alive.





The Marine Police based on information received from a cashier at Blaa Dredging Nigeria Limited, Ikorodu, Lagos, that Four (4) of their workers were missing, one of which was a Chinese national. The Marine Police, deployed a team of search party comprising of COMPOL'S Monitoring Leader, Two (2) Gunboats, Anti-crime Patrol boat and Five (5) Ex-militants, to search all over Langbasa, Ito-Owolo, Agboyi, Bayeku, Egbin, Agbowa and Ikosi. All accessible Creeks within Ikorodu and Ajah were searched for possible rescue of the missing persons and success was recorded. Parties suspected to be in connection to the kidnap were arrested and taken to the State Headquarters.

ROLES OF THE LAGOS STATE SECURITY TRUST FUND AND THE LAGOS STATE GOVERNMENT

The Marine Police appreciates the Lagos State Security Trust Fund and the State Government for the overwhelming support. This has created sustainable impact on the security architecture of the waterways of the State. The support includes the constant

provision of lubricants, regular servicing of the boats, provision of life jackets, life buoys, fire extinguishers and most importantly AGO (diesel) the running of the Armoured Combat Patrol Gunboats, and PMS (petrol) for the Fibre Gunboats and other back up boats.

Conclusively, the Marine Police, Lagos State Command, recorded a huge success throughout the period under review. Our Strategies and presence / pin down points in vulnerable flash points and places have drastically reduced crime to the barest minimum in Lagos State waterways and creeks. However, the rate at which waterway accidents occur, implies that a lot has to be done by boat owners, boat operators and other maritime stakeholders. There is need for organized awareness campaign/programmes, where waterway users will be enlightened on the need for the use of their life saving apparatus. This will in turn reduce the high rate of waterway accidents and save the lives of Nigerians residing in riverine areas of Lagos State.

A BRIEF ON THE ACTIVITIES OF THE OPERATION MESA (ARMY, NAVY & AIRFORCE)

INTRODUCTION

The OP MESA is an initiative of the Lagos State Government comprising of Military security outfit which conducts support activities to aid the civil security agencies in the discharge of their statutory responsibilities. The OP MESA outfit consists of men from the Army, the Air Force and the Navy under the command of Brigadier General L.D. Saraso Commander 9 Brigade Nigerian Army, Air Commodore Kola Ademuwagun Commander 651 Base Service Group Nigerian Air Force and Commodore Bashir Mohammed Commander NNS Beecroft respectively.

AREA OF RESPONSIBILITY

Army – A total of 10 sectors of the Nigerian Army are participants of the troops involved in the operation of the OP MESA which focuses on areas in Victoria Island, Apapa, Ikorodu, Ikeja, Badagry, Ojo, Seme Border, Mushin, Mile 2, and Epe. (Ikoyi Mile 2, Badagry, Ikeja, Ogba, Ojo, Ikorodu, Mile 12, Ajah, Lagos Island, Idi-Araba, Agbara and oil pipelines in the State).

Navy – Agege, Apapa, Ijora, Ajegunle, and some areas of Mile 2 and oil pipelines and tank farms in Lagos State.

Air Force – Ikeja, Mushin, Isolo, Apapa Ijaye, Oshodi, and Alimosho including Ikotun, Egbeda, Shasha, and its environment.

The formation which is a joint military-police patrol complements the effort of the Nigeria Police Force to provide internal security aimed at maintaining law and order in State of the Federation in line with the provisions of Section 217 of the 1999 Constitution of the Federal Republic of Nigeria. OP MESA's

primary responsibility is anti-crime patrol although they participate in joint raids of identified Black Spots with other agencies such as the Police and SSS in responding to distress calls.

(MODE OF OPERATIONS OF THE OP MESA)

OP MESA operates a 24 hour daily mobile and static patrol to their Area of Responsibility (AOR), likely black spots as a form of show of Force to deter would-be criminals and maintain a reserve to facilitate quick reinforcement or support to any mobile group when necessary.

The activities of the OP MESA are coordinated by the State Security Council chaired by Mr. Governor to ensure that the three (3) arms work together as an effective unit while the required operational requirements are provided by the State Government and the Lagos State Security Trust Fund.

The OP MESA has continued to partner with other security agencies to ensure peace and order in the State by assisting in the arrest of imposters/kidnappers and human traffickers, restraining smuggling activities and providing security in critical areas in the State.

Within the period of October 2020 to September 2021, the OP MESA has successfully accomplished the following feat:



The Nigerian Navy component of the OP MESA was involved in the clearing of illegal structures used by criminals as hid out at Liverpool Bridge and waterside area of Apapa. The structures were cleared to dislodge the criminal elements and stop illicit drug trade in the areas. In one of such clearance, a locally made pistol, cutlass and a portable axe used to attack and rob innocent residents were recovered.

There was violent clash between commercial motor cycle riders popularly known as Okada riders and Lagos State Task Force at Ikeja-Along, Ayobo, Ipaja and Oshodi-isolo on 18 November 2020 and 24 November 2020 respectively. The clash was as a result of Lagos State Government ban on the use of Okada in some parts of the State. While the clash was ongoing, Okada riders blocked major roads and burnt tires on the roads to disrupt commuters. Subsequently, NAF OP MESA Team intervened and restored normalcy in the affected areas.

On 27 August 2021 at about 0200hours, there was leakage of a pipeline belonging to NNPC at Ikotun, Lagos State. It was revealed that the vandalism was caused by suspected pipeline vandals who indulge in oil bunkering. As Premium Motor Spirit (PMS) flows through the drainage channels connecting

Omoboriowo Street, Old Garage Ikotun Junction, New Garage Ikotun Junction, Ikotun Market and Igando/Ikotun LCDA. These bunkers take delight in taping the pipes while some wreak havoc in the process. Subsequently, NAF OP MESA team conducted steady patrols around the affected area from 27 August - 28 August 2021. There was no loss of life and property in the general area. In addition, the LASEMA team commenced door to door enlightenment exercises for the general public to avoid explosion or any other secondary incident as the entire area has become highly inflammable.

CHALLENGES

In spite of the achievement the OP MESA unit requires more logistic/support such as: Patrol vehicles, equipment, protective gears (fragmented jackets and helmets) to boost its operational capacity.

CONCLUSION

The Commanding Officers of the OPMESA are most grateful to Mr. Governor Babajide Sanwo-Olu and the Lagos State Security Trust Fund for the cooperation enjoyed which has made it easy to cope with security challenges in their area of responsibilities and commits to perform to the best of their ability towards a crime free Lagos.



RETHINKING SECURITY IN LAGOS STATE

INTRODUCTION

Our nation is in a state of endemic security, costing Nigeria over \$40b worth of investment in one year [Business Day, 27 Sep, 2021]. The likelihood is that this is a reality that we have to get used to, as an existential challenge to continuously plan for, deal with, and overcome on a daily basis.

“Security endemism” does not mean unmanaged security. Rather, it makes us, as a society, shift from viewing insecurity as a one-time threat that defines us, to seeing it as part of everyday life that we must learn to endure. This in itself is not unusual. For example, approximately 41,257 died on Nigerian roads in 97 months – this is an estimated 4 persons every six hours. Each road death is a tragedy, still most people do not spend too much time thinking about road safety - we get in the car and go. Soon, the daily risks we run with security may seem as much a part of normal daily life as the risks we run when we get into our vehicles.

With this context, a new approach is required that refocus on the role of the state, citizens, enterprise and the private security sector.

To achieve this will demand a new phase of security interventions from the state, requiring new models of security services that are in sync with the national security architecture, alongside integrated security services that are solutions-based, supported by technology and deployed through outcome-based and impact-assessed operations. These will also require that the state makes conscious effort to enable private security outfits, citizens and enterprises veritable partners in security. This new paradigm to security interventions will allow security risks to be shared and collaborative between the supply and demand sides.

All the above suggests a paradigm shift on how security is deployed by Lagos state. This must be guided by defined, standard operating procedures [SoPs], with services' provisions going beyond the mundane, so as to enable innovating security solutions that meet the state's desired security outcomes. This must be coupled with strategic interactions with citizens that will make explicit the relationship between people's expectation regarding security and government's statutory responsibilities and roles in keeping the state and its assets [including people] safe and secure.

THE NEW IMPERATIVES

Noting the strategic importance and positioning of Lagos, the state needs to set goals for what the new security normal will look like and build consensus around them, with cognizance to the following.

1. Interoperability - All agencies of safety and security in Lagos state – LASTMA, LNSC, LAGESC, LASEMA etc. - must employ a wholesale approach to security services. This requires that Lagos state safety and security services must “know” and “touch” every element of our existence, as supposed to the traditional focus on physical security only. This means that that the state's security strategy and interventions must cover the entirety of our existence - food security, health security, environmental security, economic security etc. Interoperability will require a standardized model of/for multi-agency security risk assessment framework that will be adopted by all safety and security agencies that enable and ease security intelligence gathering, reporting and sharing.
2. Structured Engagement - There must be an agreed framework of/for engagement among the state's safety and security stakeholders. The engagement must engender security briefings/meetings that

has as its agenda: security incidents' trends and analytics, local and national security imperatives, current environmental factors as they impact security, threat actors at every locality and their security-risks' potentials, security education and enlightenment for the citizens and school children, sharing of best practice that could positively impact on security by agencies etc.

3. Use of Technology - This will involve Lagos state initiating new security technology that can be deployed and/or updated, alongside competencies' requirement for operatives regarding the use of technology. Government, enterprise, individuals and the private security sector must be willing to invest in security technology that are interoperable and standardized, such as access control systems, digital recognition systems, CCTV, Digital radio etc. For example, CCTV models and installation must have defined standards with state legislation to support compulsory sharing of surveillance records for intelligence gathering, investigations etc. The biometric space has never been better than it is right now, with different options for use and high level of acceptance by the majority of the population. A good place to start is the establishment of a security data bank that is linked to NIN and some form of credential authentication technology (CAT). As new security technological solutions emerge, Lagos state must be willing and able to upgrade and expand their capabilities in order to stay ahead of new and emerging security risks and threats.

4. Response Capabilities – Lagos state must have the capabilities to respond if/when there are emergencies and crisis or have partnerships with agencies or other organizations with such capabilities – and this should include the private sector, as practiced in the USA. There should be minimum, an annual emergency and crisis simulation exercise that cut across and engage all stakeholders, including services such as traffic, fire service, ambulatory services, medical teams, public health officials etc. This

exercise must ensure the development of robust capabilities that will ensure the continuity of state, enterprise and individuals' activities even during critical periods. In support of this must be a database of ex-servicemen and other relevant experts and local leadership [e.g., medics, clerics etc.] who can be assessed as resource for emergency and crisis periods.

5. Intelligence and security knowledge management – all Lagos state safety and security agencies, across all divides, must have shared processes of and for creating, sharing, using and managing security data, knowledge, information and intelligence that will assist analytics, investigations, trends mapping and predictive security. This will require the use of common communication platforms and data sharing, plus reports that reflect trends and patterns, gaps, lessons learnt, positive results recorded and nature of intervention(s) etc. with recommended actions for mitigation.

6. Capacity building and competencies development - every Lagos state safety and security operative, must have standardized and modern levels of capacities and competencies that speak to current security threats and future/anticipated security risks. A selection of them will also require specialized training that are security threats specific, alongside annual re-training schedules and plans to ensure currency of practice-knowledge. At the level of citizenship, organization should be encouraged to provide security awareness training for their employees whilst schools and institutions of learning must integrate security education as a compulsory module for all. This will enable citizens to have confidence in dealing with crimes and fear of crime whilst developing “security think”, as part of their personal capability.

7. Tracking security progress: Once realistic, multisector security goals have been established, Lagos state should track progress against them in easy-to-follow, transparent ways - this can include security-

surveillance metrics. As the state better understand the new security imperatives, monitoring systems should also include a real measurement of which interventions work and which do not. Over time, this information would let us better apply measures in a way that is grounded in real evidence. With this data and a dedicated focus, our ability to conduct meaningful predictive analysis will continue to improve. New efforts can be created, such as a Lagos State Security Intelligence Hub, where all security practice – statutory, private, informal and citizens – can share security information. Sharing of the monitoring data to stakeholders must be simple and thorough, which will inform the nature of preparedness and interventions that each security agency will deploy. As our understanding of security factors improve, our ability to make meaningful forecasts for particular security challenges will increase.

What Lagos State needs to do now.

- a. Develop a security interoperability policy to guide how all safety and security agencies' share intelligence and resources, communicate, adopt models and standards of operations. The policy must include and make explicit, the roles and functions of the private security sector and citizens
- b. Initiate legislation on the standards of electronic security solutions that can be used in the state and guidelines on their use.
- c. Develop a response system that encompass all stakeholders and organize annual emergency planning simulation exercises at each LG and LCDA. The state needs to develop a framework that can be adopted/adapted by all, with cognizance to locality-contexts
- d. A state wide training and annual re-training plan should be in place for all state safety and security operatives. This can be in partnership with the private security practitioners that have such capabilities.

e. Establish a state system for reporting, sharing, and managing safety and security intelligence across all agencies

f. Develop a database of ex-servicemen and other relevant experts and local leadership [e.g., medics, clerics etc.] who can be assessed as resource for emergency and crisis periods

g. Establish a security performance monitoring team, coordinated by LSSTF. This team will provide periodic assessment of how the state's security instruments are performance against local and international best practice, with cognizance to citizen's experiences.

CONCLUSION

Managing endemic security will require momentous societal shifts, as every stakeholder will have important roles to play. Lagos state government must be ready and willing to invest and lead on legislation, policy and strategy that has built-in consensus that are shared and communicated clearly. Enterprises will require an elevated role and responsibility in state security by striking the right balance between profitability and security imperatives. The private security sector must standardize its practice and develop operating practices that situate it as a veritable part of Lagos state's security architecture.

Perhaps the hardest of all is the mindset shift for citizens, as we slowly accept that the current state of security is not a temporary phenomenon that we can bury in our memories but rather a structural shift in how we live, thus requiring permanent changes in behavior, as safety, security become shared responsibilities.

Report on the audit of the financial statements

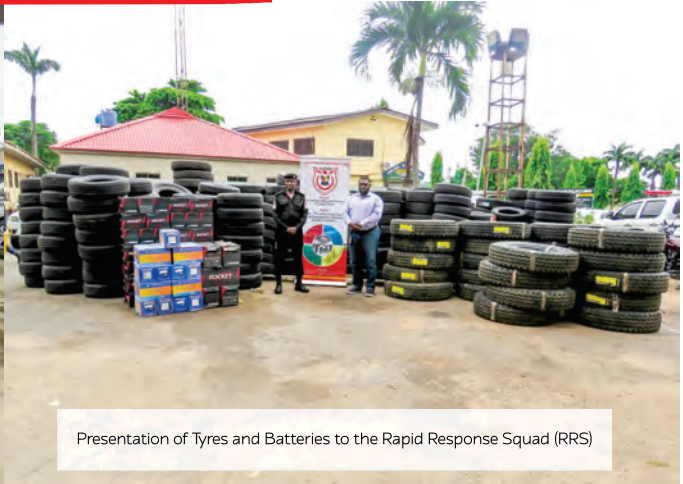
